In addition, our Recreation Program guides thousands of New Yorkers each year on interpretive paddling adventures on the river.

The Greenway Program develops open spaces, restores existing parks and integrates them into a series of continuous parks and trails along the riverthe Bronx River Greenway. The Alliance is uniquely structured to create common ground between government agencies and community-based organizations to develop the greenway.
