CHOICES is required to return any unused funds from each grant within 45 days of grant award unless an extension has been granted. CHOICES receives a \$50 Administrative Fee for providing services to the client. CHOICES does not determine eligibility for grants nor does CHOICES have a say in the criteria for grant award selection or the actual grant award selection. CHOICES does maintain records to substantiate the amount of the grant award and the amount of approved expenditures against the grant.
