## Reasonable Cause Narrative

1. The Colonial Beach Foundation (DBA: Colonial Beach Community Foundation) was founded in 2005 and approved as a 501(C)(3) organization in September of that year.
2. Since founding the community foundation has been staffed and lead by unpaid volunteers.
3. Since founding, it has consistently filed the necessary tax status form 990 postcard or N until 2018.
4. At that time, the Office of Personnel Management required a "pro forma" IRS form 990 be submitted with the Combined Federal Campaign application for non-profit participation in that program. This was done, instead of the usual 990-N or EZ per their request. The information requested was not as complete as a full 990. (Attachment A).
5. The responsibility for filing the appropriate form fell to an 82 year old volunteer, who, at the time of filing was in poor health. Thus there was confusion about the proper form and completeness of the tedious form 990.
6. The *pro forma* 990 was filed with ordinary business care and prudence and not due to willful neglect. At the time of filing, the review of omissions was unforeseeable.
7. Because the gross revenue increase was an aberration in the usual pattern of communal giving/fund raising the numbers are an outlier of expected. Still, the CBCF appears to be below the threshold of filing a full form 990. (Attachment B)



8. Since that time, corrective action has been taken and personnel more knowledgeable and skilled in tax forms have been put in place.
9. There appears to be no tax consequences for filing the incomplete form 990.
10. It would be a great imposition and create a hardship for this small, community foundation if a fine were to be levied.
