Alfanar, Inc., US's helps children, youth and women access the education, employment and empowerment needed to lead dignified and productive lives. We do this by providing funding to our affiliate Alfanar (UK registered charity) which provides tailored funding and high-management support to ambitious social enterprises, helping them to achieve lasting social change in their communities. Special focus is given to organizations that improve children's education and women's economic empowerment.

In 2018, Alfanar, Inc., US fulfilled its mission to support the education, employment and empowerment of vulnerable individuals by supporting the venture philanthropy work of Alfanar through nine grants. These grants were made in support of Alfanar's general operations, which includes vetting, conducting due diligence on, and managing venture philanthropy grants to ambitious social enterprises working to improve education and improve livelihoods. Additionally, Alfanar made restricted grants to support Alfanar's investments in widow and refugee empowerment. Alfanar, Inc., US support is integral to enabling Alfanar to monitor the performance and progress of a portfolio of 18 social enterprises across Egypt, Lebanon and refugee communities. The disbursed grants were sent exclusively for charitable or education purposes as defined under Internal Revenue Code. Alfanar, Inc., US approved nine grants to Alfanar (charity registered in England and Wales number 1105048) amounting to \$462,830. Five of these grants were dated in 2017, on the following dates: Feb. 9, Oct. 18 (2), and Dec. 14 (2), but funds were not disbursed until 2018 due to difficulties experienced with the organization's online banking system. Four of these grants were dated in 2018 on Oct. 4 (3) and Nov. 23. These were disbursed in Dec. 2018. All of these grants were approved at a total of five Board meeting held on the previously mentioned dates.

In 2018, Alfanar, Inc., US raised awareness and grew public support for the venture philanthropy and social investment movement by holding two outreach events. In October, Alfanar, Inc., US held a private screening of the 'Soufra' documentary in NYC. 'Soufra' (www.soufracom.com) is an independent documentary directed by Thomas Morgan and executive produced by Susan Sarandon, which tells the story of Alfanar's second investment in Lebanon, through which it seeded the first food truck and catering business (carrying the same name of the film) wholly owned by refugee women. The film underscores the power of the venture philanthropy approach, even in a refugee camp and shows how philanthropic capital can be directed to empower vulnerable communities to stand on their feet, self-generate revenue and move beyond dependency and aid. Around 100 people attended the NY screening. In December, Alfanar, Inc., US held a similar screening and discussion event in Boston for 150 people. Donations received through the Boston screening amounted to \$7,949.

It should be noted that in 2018 Alfanar, Inc., US disbursed grants exclusively to Alfanar (charity registered in England and Wales number 1105048), which abides by strict UK Charity Commission regulations.

Part I, line 3, column (f) & Part II, line 1: Alfanar, Inc., US employs a cash basis to account for its expenditures on financial statements.

Alfanar, Inc., US's financial statements are compiled and reviewed by an independent accountant (separate basis),

Hughes and Company, P.C. Alfanar, Inc., US's lawyers, Hurwit & Associates, also review 990 forms and respective state filings.

Alfanar, Inc., US approved nine grants to Alfanar (charity registered in England and Wales number 1105048) amounting to \$462,830

These awards are governed by grant agreements between Alfanar, Inc., US and Alfanar. Five of these were dated in 2017, on the

following dates: Feb, 9, Oct 18 (2), and Dec 14 (2). But funds were not disbursed until January 2018. Four of these were dated in 2018,

Oct, 4 (3) and Nov, 23. These were disbursed in December 2018. These Grants were approved at a total of five Board meetings held on

the previously mentioned dates. The disbursed grants were sent exclusively for charitable or educational purposes as defined under Internal Revenue Code 501 (c) 3. The grant funding deployed to Alfanar is used in accordance with the terms of the grant agreements.

Two of the grants were restricted to Alfanar's livelihoods work with refugees, one was restricted to work with Widows and the others were generally for operations that further Alfanar's venture philanthropy work in Egypt and Lebanon.

As mentioned above, all of Alfanar, Inc., US's grants were sent to the UK in 2018. The total of \$462,830 was governed by the aforementioned nine grant agreements between Alfanar, Inc., US and Alfanar which state that 'Grant funding received from Alfanar, Inc., US under the terms of this agreement will be deployed to Alfanar's general purposes and operations. The grant aims to support and bolster Alfanar's venture philanthropy work throughout the Arab region, namely to identify, vet, fund, and support the growth of ambitious social enterprises working to improve education and create steady employment for vulnerable youth and women.

Part V 1.b In 2018, Alfanar, Inc., US fulfilled its mission to support the education, employment and empowerment of vulnerable individuals by supporting the venture philanthropy work of Alfanar through nine grants. These grants were made in support of Alfanar's general operations, which includes vetting, conducting due diligence on, and managing venture philanthropy grants to ambitious social enterprises working to improve education and improve livelihoods. Additionally, Alfanar made restricted grants to support Alfanar's investments in widow and refugee empowerment.

The disbursed grants were sent exclusively for charitable or education purposes as defined under Internal Revenue Code.

Alfanar, Inc., US approved nine grants to Alfanar (charity registered in England and Wales number 1105048) amounting to \$462,830.

Five of these grants were dated in 2017, on the following dates: Feb. 9, Oct. 18 (2), and Dec. 14 (2), but funds were not disbursed until 2018 due to difficulties experienced with the organization's online banking system. Four of these grants were dated in 2018 on Oct. 4 (3) and Nov. 23. These were disbursed in Dec. 2018. All of these grants were approved at a total of five Board meeting held on the previously mentioned dates.
