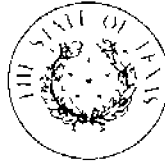

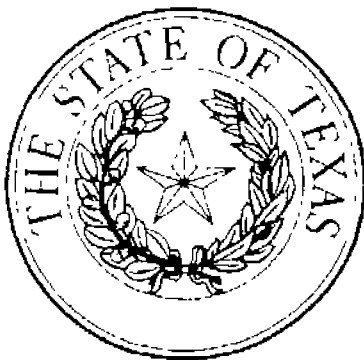

**RESTATED CERTIFICATE OF FORMATION
WITH NEW AMENDMENTS
FOR
THE SIMMONS FOUNDATION**

I. Entity Information

1. The name of the filing entity is The Simmons Foundation (the "corporation").
2. The corporation is a nonprofit corporation under Chapter 22 of the Texas Business Organizations Code (the "TBOC").
3. The file number issued to the corporation by the Secretary of State is 126821801.
4. The date of formation of the corporation is April 22, 1993.

II. Amendments to Certificate of Formation

Pursuant to the provisions of Sections 3.059, 6.201 and 22.109 of the TBOC, this restated certificate of formation makes new amendments to the corporation's Restated Articles of Incorporation filed October 18, 2005 (the "Certificate") as follows:

- (i) Article III of the Certificate is amended to change the period of duration of the corporation. The full text of such amendment is contained in Article III of the amended and restated certificate of formation attached hereto (the "Restated Certificate of Formation").
- (ii) Article V of the Certificate is amended to change the name of the registered agent. The full text of such amendment is contained in Article V of the Restated Certificate of Formation attached hereto.
- (iii) Article VI of the Certificate is amended to change the composition of the Board of Directors and condition its authority on the rights of the Corporation's members. The full text of such amendment is contained in Article VI of the Restated Certificate of Formation attached hereto.
- (iv) Article VIII of the Certificate is amended to provide that the corporation shall have members. The full text of such amendment is contained in Article VIII of the Restated Certificate of Formation attached hereto.
- (v) Article XI of the Certificate regarding the distribution of the corporation's remaining properties upon dissolution is amended to conform to Section 22.304(a) of the TBOC. The full text of such amendment is contained in Article XI of the Restated Certificate of Formation attached hereto.

- (vi) Article XII regarding indemnification is added to the Certificate. The full text of the added provision is contained in the Restated Certificate of Formation attached hereto.
- (vii) Article XIII regarding amendments is added to the Certificate. The full text of the added provision is contained in the Restated Certificate of Formation attached hereto.

In addition to the amendments described above, the Restated Certificate of Formation attached hereto amends certain provisions of the Certificate to conform the governing document to the terminology and citations contained in the TBOC and to include such other information as is required for nonprofit corporations under the TBOC.

III. Statement of Approval

Each new amendment has been made in accordance with the provisions of the TBOC. **RESTATED CERTIFICATE OF FORMATION
OF

ARTICLE I

The name of the corporation is The Simmons Foundation.

ARTICLE II

The corporation is a non-profit corporation.

ARTICLE III

Unless dissolved sooner pursuant to state law or the corporation's bylaws, the period of the corporation's duration shall be until the tenth anniversary of the death of Gay A. Roane.

ARTICLE IV

The Corporation is organized and shall be operated exclusively for religious, charitable, scientific, literary, educational and prevention of cruelty to children or animals purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or corresponding provision thereafter in effect.

ARTICLE V

The street address of the registered office is 109 N. Post Oak Lane, Suite 220, Houston, Texas 77024 and the name of its registered agent at such address is John P. Durie.

ARTICLE VI

The affairs of the corporation shall be managed by the Board of Directors, subject to the rights of the corporation's Member set forth herein or in the corporation's bylaws. The number of Directors constituting the current Board of Directors of the corporation is four (4) and the names and addresses of the persons who are currently serving as Directors are.

The number of Directors constituting the Board of Directors of the corporation may be changed in accordance with the corporation's bylaws, but shall never be less than three (3) nor more than seven (7).

ARTICLE VII

A Director of the corporation shall not be personally liable to the corporation for monetary damages for any act or omission in the Director's capacity as a Director, except for liability for (i) any breach of a Director's duty of loyalty to the corporation; (ii) acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; (iii) any transaction from which the Director received an improper benefit, whether or not the benefit resulted from an action taken within the scope of the Director's office; or (iv) acts or omissions for which the liability of a Director is expressly provided by statute. The foregoing limitation of liability to the corporation shall not be deemed exclusive of any other rights, limitations of liability or indemnity to which a Director may be entitled under any other provision of the Certificate of Formation or bylaws of the Corporation, contract or agreement, vote of Directors, principal of law or otherwise. In addition to the circumstances in which a Director shall not be liable as set forth in the preceding sentences, a Director shall not be liable to the fullest extent permitted by any provision of the statutes of Texas hereafter enacted that further limits the liability of a Director. This provision shall in no way limit or relieve a Director of any liability for federal excise taxes under Chapter 42 of the Code.

ARTICLE VIII

The Corporation shall have a member ("Member"), the qualifications and rights of which shall be as set forth in the bylaws of the corporation.

ARTICLE IX

Regardless of any other provisions of this Certificate of Formation or the laws of the State of Texas, the corporation shall not:

- (1) Permit any part of the net earnings of the corporation to inure to the benefit of any private individual (except that reasonable compensation may be paid for personal services rendered to or for the corporation affecting one or more of its purposes);
- (2) Carry on propaganda, or otherwise attempt to influence legislation;
- (3) Participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office; or

- (4) Attempt to influence the outcome of any specific public election or to carry on, directly or indirectly, any voter registration drives.

ARTICLE X

If the corporation is a private foundation within the meaning of section 509(a) of the Code, or corresponding provisions of any subsequent federal tax laws, the corporation:

- (1) Shall distribute its net income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code, or corresponding provisions of any subsequent federal tax laws;
- (2) Shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code, or corresponding provisions of any subsequent federal tax laws;
- (3) Shall not retain any excess business holdings as defined in Section 4943(c) of the Code, or corresponding provisions of any subsequent federal tax laws;
- (4) Shall not make any investments in such manner as to subject it to tax under Section 4944 of the Code, or corresponding provisions of any subsequent federal tax laws; and
- (5) Shall not make any taxable expenditures as defined in Section 4945(d) of the Code, or corresponding provisions of any subsequent federal tax laws.

ARTICLE XI

Pursuant to Section 22.304(a) of the TBOC, after all liabilities and obligations of the corporation in the process of winding up are paid, satisfied and discharged, the property of the corporation shall be applied and distributed as follows:

- (1) Property held by the corporation on a condition requiring return, transfer, or conveyance because of the winding up or termination shall be returned, transferred, or conveyed in accordance with that requirement.
- (2) The remaining properties of the corporation shall be distributed to one or more organizations which are (i) described in Section 501(c)(3) of the Code and (ii) not treated as a "private foundation" within the meaning of Section 509(a) or any other provision of the Code. Unless designated in the corporation's bylaws, such organizations and the division of the remaining properties among such organizations shall be determined by majority vote of the Board of Directors.

ARTICLE XII

The corporation may indemnify a person who was, is, or is threatened to be made a named defendant or respondent in litigation or other proceedings because the person is or was a Director or other person related to the corporation, to the extent provided by Chapter 8 of the

TBOC. The Board of Directors shall have the power in the corporation's bylaws to define the requirements and limitations for the corporation to indemnify Directors, officers, or others related to the corporation.

ARTICLE XIII

This Certificate of Formation may be amended by the affirmative vote of at least two-thirds of the Members present at any annual, regular or special meeting, provided that Articles III, IV, VIII and XI may be amended only if Gay A. Roane is a Member at the time such amendment is to be made, and provided further that the notice for any special meeting at which amendments to this Certificate of Formation will be considered includes a description of such amendments.

**AMENDED AND RESTATED BYLAWS
OF
THE SIMMONS FOUNDATION**

**ARTICLE I
STRUCTURE, PURPOSES AND MEMBER**

Section 1. Structure The Simmons Foundation (the "Foundation") is a nonprofit corporation organized under the laws of the State of Texas, which has members within the meaning of section 1.002(53) of the Texas Business Organizations Code, (the "TBOC"). The original Articles of Incorporation of the Foundation were filed in the office of the Secretary of State of the State of Texas on April 22, 1922, were amended and restated by Restated Articles of Incorporation of the Foundation filed in the office of the Secretary of State of the State of Texas on August 11, 1994, and subsequently were amended and restated by the Restated Articles of Incorporation (With Amendments) filed in the office of the Secretary of State of the State of Texas on October 18, 2005 (the "2005 Articles"). Pursuant to sections 3.059 and 22.109 of the TBOC, the 2005 Articles were amended and restated into the Restated Certificate of Formation of the Foundation filed in the office of the Secretary of State of the State of Texas on October 10, 2018 (collectively, and as further amended and or restated from time to time, the "Certificate of Formation").

Section 2. Duration As set forth in the Certificate of Formation, unless dissolved sooner pursuant to state law or these Bylaws, the Foundation shall dissolve and wind-down its affairs no later than the date that is ten (10) years after the date of death of the Initial Member (as defined herein). In winding down the affairs of the Foundation, during each of the wind-down fiscal years following the death of the Initial Member, the assets of the Foundation shall be distributed (i) as grants to organizations which are exempt from federal income taxation as a result of being described in section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") and other than a private foundation within the meaning of section 509(a) of the Code ("Public Charities") that have been in existence for five or more years as of the date of the grant and will further the Initial Member's charitable intentions as described in the Statement of Donor Intent attached hereto as Appendix A (the "Donor Statement") and (ii) for the payment of reasonable expenses to operate and wind-down the affairs of the Foundation. Such distributions and payments shall be made in the following minimum amounts in each wind-down fiscal year following the death of the Initial Member, such first wind-down fiscal year beginning on the date of death of the Initial Member:

(a) First Wind-down Fiscal Year – At least 1/10 (10%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(b) Second Wind-down Fiscal Year – At least 1/9 (11%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(c) Third Wind-down Fiscal Year – At least 1/8 (12.5%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(d) Fourth Wind-down Fiscal Year – At least 1/7 (14.3%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(d) Fourth Wind-down Fiscal Year – At least 1/7 (14.3%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(e) Fifth Wind-down Fiscal Year – At least 1/6 (16.7%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(f) Sixth Wind-down Fiscal Year – At least 1/5 (20.0%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(g) Seventh Wind-down Fiscal Year – At least 1/4 (25.0%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(h) Eighth Wind-down Fiscal Year – At least 1/3 (33.3%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(i) Ninth Wind-down Fiscal Year – At least 1/2 (50.0%) of the fair market value of the assets of the Foundation as of January 1 of such wind-down fiscal year.

(j) Tenth Wind-down Fiscal Year – All remaining assets of the Foundation shall be distributed no later than the date that is the tenth anniversary of the death of the Initial Member.

Section 3. Purposes

The Foundation is organized and will be operated exclusively for the tax exempt purposes set forth in the Certificate of Formation.

(a) In carrying out such exempt purposes after the death of the Initial Member, the Board of Directors shall operate the Foundation and make decisions regarding the areas and charitable organizations to be supported by the Foundation in a manner that will further her charitable intentions as described in the Donor Statement.

(b) All support by the Foundation shall be in the form of grants to Public Charities. Distributions may include part or, if conditions variant or are otherwise required herein, all of the assets of the Foundation in the sole discretion of the Board.

Section 4. Member

The Foundation shall have one member (the "Member"). The initial Member of the Foundation is Gay A. Roane (the "Initial Member").

ARTICLE II **OFFICES**

Section 1. Principal Place of Business

The principal place of business of the Foundation is located at 109 N. Post Oak Lane, Suite 212, Houston, Texas 77024. The Foundation may have such other offices, either within or without the State of Texas, as the Board of Directors may determine or as the affairs of the Foundation may require from time to time.

Section 2. Registered Office and Registered Agent

The Foundation shall have and continuously maintain in the State of Texas a registered office and a registered agent whose office is the Foundation's registered office, as required by the TBOC. The registered office may but need not be identical to the principal office of the Foundation in the State of Texas, and the address of the registered office may be changed from time to time by the Board of Directors in accordance with applicable law.

ARTICLE III
MEMBER

Section 1. General

The Member of the Foundation shall have the rights, powers, and privileges granted under these Bylaws.

Section 2. Election and Removal of Directors

The Member shall elect the members of the Board of Directors, and may remove from office at any time, with or without cause any member of the Board of Directors in accordance with Article IV of these Bylaws.

Section 3. Term; Appointment of Successor Member

(a) Each person serving as the Member shall serve until the earlier of his or her death, incapacity or resignation

(b) For so long as Gay A. Roane is serving as the Member, the Member may appoint at any time any person to serve as the Member effective upon the then-serving Member's resignation, incapacity or death. Appointment shall be made by written instrument signed by the Member and delivered to the President or Secretary. Any such appointment may be changed or revoked prior to the date it becomes effective. For purposes of this Section 3, "incapacity" shall mean the inability of the Member to manage his or her personal financial affairs, if certified in a written declaration signed by a physician who has treated the Member in the six-month period immediately preceding the date of such declaration. No Member other than Gay A. Roane may appoint a Member.

(c) If, upon the resignation, incapacity or death of the Member, such Member has not appointed a person to succeed him or her as the Member in accordance with Section 3(b) of this Article III, then the Foundation shall operate as a non-member corporation thereafter, and all powers vested by these Bylaws in the Member shall be exercisable by the Board of Directors.

Section 4. Action by Written Consent

Any action required by law to be taken at a meeting of the Member may be taken without a meeting if a consent in writing setting forth the action to be taken is signed by the Member. Such written consent shall state the date of the Member's signature. Such written consent shall have the same force and effect as a vote of the Member at a meeting.

Section 5 Compensation of Member; Expenses

The Member shall not receive any salary or compensation for services as the Member.

Section 6. Income

No Member shall be entitled to any dividends or any part of the income of the Foundation or to share in the distribution of the Foundation's assets upon dissolution.

Section 7. Member's Right to Inspect Books and Records

The Member shall be entitled to examine, and copy at the Member's expense, the books and records of the Foundation, as required by law, at any reasonable time and for a proper purpose, upon demand in writing

ARTICLE IV
BOARD OF DIRECTORS

Section 1. Powers

The property, business, and affairs of the Foundation shall be managed and controlled by the Board of Directors, subject to the rights of the Member set forth herein or in the Certificate of Formation, and subject to the restrictions imposed by law, the Certificate of Formation and these Bylaws, the Board of Directors shall exercise all of the powers of the Foundation

Section 2. Number

As of the date of these Bylaws, the Board of Directors consists of four (4) directors. The number of directors may be increased or decreased from time to time by amendment of these Bylaws in accordance with the provisions of Article X, provided that the number of directors shall never be less than three (3) nor more than seven (7).

Section 3. Appointment and Term

Directors shall be appointed by the Member. Each person serving as a director shall hold office until the earlier to occur of such person's death, resignation, or removal as hereinafter provided.

Section 4. Removal

Any director may be removed from office, with or without cause, by the Member

Section 5. Election and Vacancies

Any vacancy occurring in the office of a director, whether by death, resignation, removal, or otherwise, shall be filled by the Member. Any vacancy to be filled by reason of an increase in the number of directors shall be filled by the Member.

Section 6. Meetings of Directors

The directors may hold meetings, maintain an office, and keep the Foundation's books and records at such place or places within or without the State of Texas as the Board of Directors may from time to time determine, provided, however, that in the absence of any such determination, such place shall be the Foundation's principal office in the State of Texas

Section 7. Annual Meetings

The annual meeting of the Board of Directors ("Annual Meeting") shall be held at such time and place as shall be designated from time to time by resolution of the Board of Directors for the purpose of (a) electing officers for the ensuing year, and (b) transacting such other business as may be properly brought before such Annual Meeting. Notice of Annual Meetings shall be required. The Secretary shall give notice of the time and place of the Annual Meeting to each director at least ten (10) calendar days before such meeting.

Section 8. Regular Meetings

In addition to the Annual Meeting, regular meetings of the Board of Directors ("Regular Meetings") shall be held at such times and places as shall be designated from time to time by resolution of the Board of Directors. Notice of Regular Meetings shall be required. The Secretary shall give notice of the time and place of each Regular Meeting to each director at least ten (10) calendar days before such meeting. There shall be a minimum of three (3) Regular Meetings per full calendar year (in addition to the Annual Meeting), provided, no more than one Annual Meeting or Regular Meeting shall be required in a calendar quarter for any year that is less than a full calendar year.

Section 9. Special Meetings

Special meetings of the Board of Directors ("Special Meetings") shall be held at such times and places as shall be designated from time to time by (a) the Chairman of the Board, (b) the President or (c) by the Secretary, if the Secretary is requested to do so in writing by a majority of the then-serving directors. Notice of Special Meetings shall be required. The Secretary shall give notice of the time and place of each Special Meeting to each director at least ten (10) calendar days before such meeting. Unless otherwise indicated in such notice, any and all matters pertaining to the Foundation's purposes may be considered and acted upon at such meeting. At any such meeting at which every director shall be present even though without notice, any matter pertaining to the Foundation's purposes may be considered and acted upon.

Section 10. Quorum

A majority of the then-acting directors shall constitute a quorum for the consideration of any matters pertaining to the Foundation's purposes. If at any meeting of the Board of Directors there is less than a quorum present, a majority of those present may adjourn the meeting from time to time. The act of a majority of the directors present at a meeting at which a quorum is present shall be the act of the Board of Directors, unless the act of a greater number is required by law, the Certificate of Formation or these Bylaws.

Section 11. Voting

Proxy voting shall not be allowed

Section 12. Conduct of Business

At meetings of the Board of Directors, matters pertaining to the Foundation's purposes shall be considered. At all meetings of the Board of Directors, the Chairman of the Board shall preside, and in the absence of the Chairman of the Board, a Chairman shall be chosen by the Board of Directors from among the directors present. The Secretary of the Foundation shall act as secretary of all meetings of the Board of Directors, but in the absence of the Secretary, the Chairman may appoint any person to act as secretary of the meeting.

Section 13. Chairman of the Board

The Board of Directors shall appoint from among its members a Chairman of the Board, who shall serve in such position until such person's death, resignation, or removal, or if earlier, the date such person ceases to serve as a director. The Chairman of the Board shall preside at all meetings of the Board of Directors, and shall have such powers and duties as may be assigned from time to time by the Board of Directors. A duly-appointed Chairman of the Board may be removed from such position, with or without cause, by the affirmative vote of a majority of the other then-acting directors.

Section 14. Executive Committee

The Board of Directors may, by resolution passed by a majority of the directors in office and with the consent of the Member designate two (2) or more members of the Board of Directors to constitute an Executive Committee, which committee shall have and may exercise, except where action of the Board of Directors is specified by statute, such powers as a majority of the Board of Directors may determine in the resolution that creates the Executive Committee. The Executive Committee so designated shall keep regular minutes of the transactions of its meetings and shall cause such minutes to be recorded in books kept for that purpose in the office of the Foundation, and shall report the same to the Board of Directors from time to time.

Section 15. Compensation of Directors; Expenses

Persons serving as directors shall not receive any salary or compensation for services as directors; provided, however, that nothing contained herein shall be construed as precluding any director from receiving compensation in a reasonable amount for their services as an officer of the Foundation. A director shall be entitled to reimbursement for Reasonable Expenses (as defined in Section 7 of Article VIII) incurred in carrying out such person's duties as a director.

ARTICLE V
OFFICERS

Section 1. Number, Titles, and Term of Office

The officers of the Foundation shall consist of a President, one or more Vice-Presidents, a Secretary, a Treasurer, and such other officers and assistant officers as the Board of Directors may from time to time elect or appoint. Such other officers and assistant officers shall have such authority and responsibility as may be assigned to them by the Board of Directors. Any two (2) or

more offices may be held by the same individual, except that the President shall not also hold the office of Secretary. A duly-elected officer shall serve in such office until a successor has been duly elected and qualified, or until such person's earlier death, resignation or removal.

Section 2 Removal

Any officer or agent or member of a committee elected or appointed by the Board of Directors may be removed by the Board of Directors, but such removal shall be without prejudice to the contract rights, if any, of the individual so removed. Election or appointment of an officer or agent or member of a committee shall not of itself create contract rights.

Section 3 Vacancies

Any vacancy occurring in any office of the Foundation may be filled by the Board of Directors.

Section 4. Powers and Duties of the President

The President shall be the principal executive officer of the Foundation. Subject to the control of the Board of Directors, the President shall have general executive charge, management, and control of the properties, business, and operations of the Foundation with all such powers as may be reasonably incident to such responsibilities; shall have the authority to agree upon and execute all leases, contracts, evidences of indebtedness, and other obligations in the name of the Foundation subject to the approval of the Board of Directors, and shall have such other powers and duties as may be designated in these Bylaws and as may be assigned to such officer from time to time by the Board of Directors.

Section 5 Powers and Duties of a Vice-President

Each Vice-President shall have such powers and duties as may be assigned to such officer by the Board of Directors including the performance of the duties of the President upon the death, absence, or resignation of the President or upon the President's inability to perform the duties of such office. Any action taken by a Vice-President in the performance of the duties of the President shall be conclusive evidence of the absence or inability to act of the President at the time such action was taken.

Section 6. Powers and Duties of the Treasurer

The Treasurer shall have custody of all of the Foundation's funds and securities that come into such officer's hands. When necessary or proper, the Treasurer may endorse or cause to be endorsed, in the name and on behalf of the Foundation, checks, notes, and other obligations for collection and shall deposit or cause to be deposited the same to the credit of the Foundation in such bank or banks or depositories and in such manner as shall be designated and prescribed by the Board of Directors; may sign or cause to be signed all receipts and vouchers for payments made to the Foundation either alone or jointly with such other officer as may be designated by the Board of Directors; whenever required by the Board of Directors, shall render or cause to be rendered a statement of the cash account; shall enter or cause to be entered regularly in the Foundation's books to be kept by such officer for that purpose full and accurate accounts of all

moneys received and paid out on account of the Foundation; shall perform all acts incident to the position of Treasurer subject to the control of the Board of Directors, and shall, if required by the Board of Directors, give such bond for the faithful discharge of such officer's duties in such form as the Board of Directors may require

Section 7. Powers and Duties of the Secretary

The Secretary shall keep the minutes of all meetings of the Board of Directors in books provided for that purpose; shall attend to the giving and serving of all notices; in furtherance of the Foundation's purposes and subject to the limitations contained in the Certificate of Formation, may sign with the President in the name and on behalf of the Foundation and/or attest the signatures thereto, all contracts, conveyances, franchises, bonds, deeds, assignments, mortgages, notes, and other instruments of the Foundation, shall have charge of the Foundation's books, records, documents, and instruments, except the books of account and financial records and securities of which the Treasurer shall have custody and charge, and such other books and papers as the Board of Directors may direct, all of which shall be open at reasonable times to the inspection of any director upon application at the Foundation's office during business hours, and shall in general perform all duties incident to the office of Secretary subject to the control of the Board of Directors

Section 8. Compensation of Officers

Officers shall be entitled to receive salary or compensation in a reasonable amount for services rendered that are necessary and reasonable in carrying out the Foundation's purposes as the Board of Directors may from time to time determine provided, however, that in no event shall such salary or compensation be excessive. An officer shall be entitled to reimbursement for Reasonable Expenses (as defined in Section 7 of Article VIII) incurred in carrying out such person's duties as an officer

ARTICLE VI
INDEMNIFICATION OF DIRECTORS AND OFFICERS

Section 1. Right to Indemnification

Directors and officers of the Foundation shall be indemnified by the Foundation to the fullest extent allowable under chapter 8 of the TBOC or the provisions of any other applicable law

Section 2. Advance Payment

The right to indemnification conferred in this Article VI shall include the right to be paid or reimbursed by the Foundation the reasonable expenses incurred by a director or an officer who was, is or is threatened to be made a named defendant or respondent in a proceeding in advance of the final disposition of the proceeding; provided, however, that the payment of such expenses incurred by a current or former director or officer in advance of the final disposition of a proceeding, shall be made only upon delivery to the Foundation of a written affirmation by such director or officer of his or her good faith belief that he or she has met the standard of conduct necessary for indemnification under this Article VI and a written undertaking, by or on behalf of such director or officer, to repay all amounts so advanced if it shall ultimately be determined that such indemnified person is not entitled to be indemnified under this Section 2 or otherwise.

Section 3. Indemnification of Employees and Agents

The Foundation may indemnify and advance expenses to an employee or agent of the Foundation to the same extent and subject to the same conditions under which it may indemnify and advance expenses to directors and officers under this Article VI; and, the Foundation may indemnify and advance expenses to persons who are not or were not directors, officers, employees or agents of the Foundation but who are or were serving at the request of the Foundation as a director, officer, partner, venturer, proprietor, director, employee, agent or similar functionary of another foreign or domestic corporation, partnership, joint venture, sole proprietorship, trust, employee benefits plan or other enterprise against any liability asserted against him and incurred by him in such a capacity or arising out of his status as such a person to the same extent that it may indemnify and advance expenses to directors under this Article VI.

Section 4. Appearance as a Witness

Notwithstanding any other provision of this Article VI, the Foundation may pay or reimburse expenses incurred by a director or officer in connection with his or her appearance as a witness or other participation in a proceeding at a time when he or she is not a named defendant or respondent in the proceeding.

Section 5. Nonexclusivity of Rights

The right to indemnification and the advancement and payment of expenses conferred in this Article VI shall not be exclusive of any other right which a director or officer or other person indemnified pursuant to Section 3 of this Article VI may have or hereafter acquire under any law (common or statutory), provision of the Certificate of Formation or these Bylaws, agreement, vote of disinterested directors or otherwise.

Section 6. Insurance

The Foundation may purchase and maintain insurance, at its expense, to protect itself or any person who is or was serving as a director, officer, employee or agent of the Foundation or is or was serving at the request of the Foundation as a director, officer, partner, venturer, proprietor, director, employee, agent or similar functionary or another foreign or domestic corporation, partnership, joint venture, proprietorship, employee benefit plan, trust or other enterprise against any expense, liability or loss, whether or not the Foundation would have the power to indemnify such person against such expense, liability or loss under this Article VI.

Section 7. Savings Clause

If this Article VI or any portion hereof shall be invalidated on any ground by any court of competent jurisdiction, then the Foundation shall nevertheless indemnify and hold harmless each director, officer or any other person indemnified pursuant to Section 3 of this Article VI as to costs, charges and expenses (including attorneys' fees), judgments, fines, and amounts paid in settlement with respect to any action, suit or proceeding, whether civil, criminal, administrative or investigative to the full extent permitted by any applicable portion of this Article VI that shall not have been invalidated and to the fullest extent permitted by applicable law including chapter 8 of the TBOC.

Section 8. Limitation on Indemnification of a Private Foundation

Notwithstanding any other provision of this Article VI, if the Foundation is a private foundation within the meaning of section 501(a) of the Code, the right to indemnification conferred in this Article VI shall not include any rights to indemnification which would constitute a violation of chapter 42 of the Code

ARTICLE VII
CONFLICTS OF INTEREST POLICY

Section 1. Conflicts of Interest Policy

The Foundation shall maintain a Conflict of Interest Policy at all times

ARTICLE VIII
MISCELLANEOUS PROVISIONS

Section 1. Fiscal Year

The Foundation's fiscal year shall be as determined from time to time by the Board of Directors.

Section 2. Seal

The Foundation's seal, if any, shall be such as may be approved from time to time by the Board of Directors

Section 3. Notice and Waiver of Notice

Whenever any notice is required under the provisions of these Bylaws, such notice may be given in person or by mail, facsimile transmission, electronic message or telephone. Notice by mail shall be deemed to be delivered when deposited in the United States mail in a sealed postpaid wrapper addressed to the person entitled thereto at such person's post office address, as such appears in the records of the Foundation, and such notice shall be deemed to have been given on the date of such mailing. If transmitted by facsimile or electronic message, such notice shall be deemed to be delivered upon successful transmission of the facsimile or electronic message. Any person entitled to notice may waive notice of any meeting. Attendance or participation at a meeting shall constitute a waiver of notice of such meeting unless such attendance or participation is for the purpose of objecting to the failure of notice. A waiver of notice in writing signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be deemed equivalent to notice

Section 4. Resignations

The Member, any director, officer, committee or advisory board member may resign at any time. Such resignation shall be made in writing and, except as otherwise provided in these Bylaws, shall take effect at the time specified therein, or, if no time be specified, at the time of its receipt

by the President or Secretary. The acceptance of a resignation shall not be necessary to make it effective, unless expressly so provided in the resignation.

Section 5. Action Without a Meeting by Directors

Any action required or authorized to be taken under the TBOC or the Certificate of Formation at a meeting of the Board of Directors or a committee may be taken without holding a meeting, providing notice, or taking a vote if each person entitled to vote on the action signs a written consent or consents stating the action taken. Such consent shall have the same force and effect as a unanimous vote at a meeting, and may be stated as such in any document or instrument filed with the Secretary of State.

Section 6. Telephone Meetings

Subject to the requirements of law for notice of meetings, unless otherwise restricted by the Certificate of Formation or these Bylaws, members of the Board of Directors or members of any committee may participate in and hold a meeting of the Board of Directors or committee, as the case may be, by means of a conference telephone or similar communications equipment, or another suitable electronic communications system, including videoconferencing technology or the Internet, or any combination, if the telephone or other equipment or system permits each person participating in the meeting to communicate with all other persons participating in the meeting. Participation in such meeting shall constitute presence in person at such meeting unless the participation is for the express purpose of objecting to the transaction of business at the meeting on the ground that the meeting has not been lawfully called or convened. If voting is to take place at the meeting, the Foundation must:

(a) Implement reasonable measures to verify that every person voting at the meeting by means of remote communications is sufficiently identified, and

(b) Keep a record of any vote or other action taken.

Section 7. Reasonable Expenses

"Reasonable Expenses" shall mean those direct out-of-pocket expenses incurred by the Member, directors, officers and employees in the performance of duties owed to the Foundation that are (i) documented to the satisfaction of the President or Board of Directors, (ii) approved by the President or the Board of Directors in a manner consistent with Expense Approval Guidelines previously adopted by the Board of Directors, (iii) directly related to the Foundation's activities, and (iv) not excessive.

ARTICLE IX
AMENDMENTS

Section 1. In General

Except as provided in Section 2 of this Article IX, these Bylaws may be altered, amended, or repealed by the Member, or if the Foundation has no Member, by the affirmative vote of a majority of the members of the Board of Directors.

Section 2. Limited Amendments

Sections 2 and 3 of Article I, Article III; Sections 3, 4 and 5 of Article IV; and this Article IX may be altered, amended or repealed only by the Initial Member, and if the Initial Member has ceased to be the Member, such sections or articles may not be altered, amended or repealed in any manner.

Appendix A

Amended and Restated Bylaws of The Simmons Foundation

Statement of Donor Intent

September 6, 2018

The purpose of this Statement of Donor Intent is to memorialize the Initial Member's intent for grants to be made from The Simmons Foundation (the "Foundation") during the ten-year wind-down period (the "Wind-Down Period") of the Foundation as specified in Article I, Section 2 of the Amended and Restated Bylaws of The Simmons Foundation (the "Bylaws"). See Attachment A for a detailed description of the Foundation's values and investment preferences.

During the Wind-Down Period it is the express written desire of the Initial Member that the board of directors of the Foundation (the "Board") be faithful to the following criteria.

1. Grant recipients must be classified as 501(c)(3) public charities and must have been in existence for five or more years prior to the date of the grant
2. Grants must be approved by a majority of the Board and must be consistent with the Bylaws.
3. The Board shall take into consideration the geographic focus and types of recipients of Foundation grants made during the lifetime of the Initial Member to serve as a guide in determining the geography and types of grants and grant recipients during the Wind-Down Period. While the Board shall have no obligation to provide grants to specific past recipients, it shall have an obligation to continue funding organizations consistent with the Initial Member's values and intent
4. The Initial Member recognizes that the number of annual grants and the average size of grants may increase during the Wind-Down Period
5. Grants in excess of \$500,000 (whether single year or multi-year grants) shall require unanimous approval from the Board
6. Grants may not be made in an amount which exceeds 10% of the Grantee's estimated total receipts unless such grant is a Capital Grant (defined below) or has unanimous approval of the Board
7. The Board shall give priority to grants focused on health, youth, civic and community and human services.
8. The Board shall remain committed to the Initial Member's values of Equity, Inclusion, Respect and Empathy as further described in Attachment A.
9. Grants for capacity building and advocacy, as further described in Attachment A, are permitted and encouraged, subject to tax regulations as such tax regulations may be modified over time.
10. Grants for capital projects ("Capital Grants") may be made, however the Initial Member does not wish the Foundation or the Initial Member's name to be used with respect to any "naming rights" associated with the Capital Grant and further restricts the amount of

Capital Grants to no greater than \$2,000,000 to any single grantee. Further, aggregate Capital Grants during the Wind-Down Period may not exceed 25% of the Foundation's total assets as of the date of death of the Initial Member after giving consideration to the assets transferred from the Initial Member's estate to the Foundation

11. The Simmons Foundation shall not fund faith-based organizations.
12. Grants shall not be made to organizations that deny services or assistance to clients related to access or comprehensive information related to family planning, contraception, or abortion services, if these services are within the scope of the prospective grantee's services.
13. Grants shall not be made to organizations that restrict services based on sexual orientation, gender identity or gender expression.
14. The Foundation shall continue to support a healthy mixture of organizations ranging in size from small, grassroots organizations to larger institutions with an alignment of values and focus.

The provisions and guidelines described herein may be changed by the Initial Member during her lifetime without further action of the Board by providing a revised Appendix A – Statement of Donor Intent to the Chairman of the Board and the President and Chief Executive Officer of the Foundation.

The Initial Member expects administrative costs of operating the Foundation to be reasonable given the size and scope of the Foundation's activities. The goal is to maintain a lean operating model, whereby the Board and staff seek efficiency and seek to maintain the Foundation's historical record of spending more on grantmaking than operational costs. Accordingly, annual operating expenses are expected to be no more than 1 to 2% of the Foundation's total assets as of the beginning of each fiscal year.
