

MISSIONARY PROGRAM Every Village pulled out our last missionaries from the field for personal health and strategic reasons. We have handed over full leadership of compound maintenance and programs (radio and water) to our team of nationals. Across all of our locations in Africa, we had 38 African employees managing the work. We officially closed our Missionary Program and converted the name to be called Training Program which more appropriately encompasses our future emphasis on supporting the spiritual and professional development of our staff through short term trainings, mid term internships, and long term education.

Form 990, Part III, Line 4b:

RADIO PROGRAM Every Village continued the operations of our 3 radio stations beginning the year with 13 total staff members. We also distributed 12,000 solar-powered radios which brought our total distributed all-time to 100,000. These radios are fixed-tuned to our stations and continue to significantly broaden the accessibility and popularity of our stations. We hosted our fourth annual pastors conference at our station in Aweil and had 823 pastors attend the two day conference. We also held our second annual radio listener support campaign at this station and over two weeks we received 876 pastors bringing contributions from 59,338 church members of over 4 million South Sudanese Pounds (over \$20,000) which covers nine months of operating expenses.

WATER PROGRAM Every Village drilled 10 new water wells in 2018 which took our total drilled all-time to 149. These water points meet an immediate physical need and provide us a stronger ministry platform within those communities. We also began a strategic review on our water program to evaluate opportunities to improve our commitment to sustainable solutions. We ended the year by budgeting to begin some pilot programs in 2019 focused on lowering drilling cost, testing new technologies, and introducing a basic spare parts supply chain.
