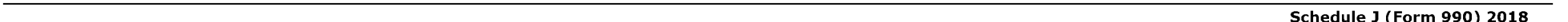

A BOARD OF DIRECTORS COMMITTEE, WHICH SHALL CONSIST SOLELY OF DISINTERESTED INDIVIDUALS WHO DO NOT DIRECTLY OR INDIRECTLY RECEIVE MORE THAN AN INSIGNIFICANT AMOUNT OF COMPENSATION FROM PGH, WILL BE ESTABLISHED TO SET AND MANAGE APPROPRIATE COMPENSATION LEVELS FOR THE PRESIDENT AND EXECUTIVE DIRECTOR. THIS COMMITTEE WILL ALSO REVIEW ON AN ANNUAL BASIS THE LEVELS OF REIMBURSEMENT FOR BOARD OF DIRECTORS TRAVEL AND OTHER EXPENSES AND ANY OTHER PAYMENTS TO DIRECTORS FOR SERVICES. AS PART OF ITS DUE DILIGENCE, THE COMPENSATION COMMITTEE SHALL RELY ON APPROPRIATE COMPARATIVE DATA, INCLUDING SALARY DATA FROM SURVEYS, COMPENSATION LEVELS FOR SIMILAR POSITIONS IN BOTH EXEMPT AND TAXABLE ORGANIZATIONS, AND REGIONAL ECONOMIC DATA. THE COMPENSATION COMMITTEE SHALL ALSO DOCUMENT THE BASIS UPON WHICH IT RELIES FOR ITS COMPENSATION DETERMINATIONS.
