The MBKSA network is comprised of 21 cross sector partners working together to change outcomes for boys and young men of color. Our focus areas drive towards increasing post-secondary attainment. During 2018 the network received data dashboards that gave partners a better understanding of current barriers for boys and young men of color. Based on this data the network was able to execute the following three high school summits supporting college and career readiness for over 300 high schoolers mentorship for over 200 young people throughout the Alamo College District and a city policy change for the decriminalization of the San Antonio Youth Curfew ordinance which disproportionately impacts boys and young men of color.

P16 Plus of Greater Bear County dba UP Partnership drives the grant-funded initiative Guiding Pathways. Guiding Pathways convenes five district partners and seven higher education institutions to align dual credit curriculum, operations, and advising. In 2018, partner institutions were convened 4 times to develop dual credit alignment priorities and action plans. Additionally, the Guiding Pathways initiative supports the Diplomas network which is made up of seventeen cross-sector partners working to improve Latino student success with a focus on college readiness and attainment. In 2018, Diplomas partners were convened 30 times to develop action plans based on student outcome data.
