Health, Education, and Advocacy. Besides continuing to provide health, education, and advocacy for over 200 East women and children to gain access to healthcare, education, and advocacy, this year our activities focused on youth of families education and physical well-being. We offered three core programs: tutoring, girls scout, and youth scholar. One, the tutorial program focus on homework assistance for K-12 was held weekly. In a culturally appropriate environment, volunteer tutors from Point Loma Nazarine tutored 40 East African youth enabling them to gained a better understanding of the subject matter, and to interacts with their peers. Two, the East African Girl's scout program thrived. Fifteen girls learned to wok together and engaged in activities such as learning how to cook healthy food, money management, marketing and the selling cookies. Furthermore, the girls learned the importance of taking roespensibilitoc and comploting their task in appropriate time framo. Third, we established a Youth Scholars program for East African boys from 5-17. The boys are divided into age appropriate groups and discussed topics such as bullying, financial literacy, and to discuss their experiences in schools and other public venues. Equally important, we continued our "Women Only" swim classes and girls basketball program at the Priice- Copley YMCA.

Female Genital Cutting Prevention. Under the auspices of Department of Health and Human Service Agency(Office of Assistant Secretary of Health Prevention Project) UWEAST continues to provide the following services to East African women whom are affected:

1. Staff Training and Preparation. We trained staff of UWEAST on how to conduct the focus groups, interviews, as well as surveys by taking the Dunya Facilitator Training.

2. Recruitment. Our recruitment strategy of going to places where community member frequent on a regular basis has been fruitful. Our outreach efforts focus on mosques, churches, adult schools, and farmer's market. 50 people are recruited on average.

3. Education: We continue to promote Dialogue with Doctors, special clinic, and other community events.

Mental Health for East African Young Men and Boys. As the lead agency, UWEAST continued to participate in Making Connocation Initiative (Prevention Institute) with our partners: UCSD Community Health Center, African Coalition Workforce, Partnership for the Advancement of New Americans, and Southern Sudanese Community Center to advance the mental health of 1st and 2nd generation East African refugees men and boys, age 15-26, in the urban areas of San Diego. Through our youth-led culturally-literated and responsive behavioral health and psychological wellness hub, we implemented the following strategic to improve the montal well being belof East African young men and boys: 1)Youth successfully advocated for an increased investment in formal and dedicated stream of Behavioral Health (BH) investment from SD County. 2)Youth identified issues and solutions related to strengthening and increasing accessibility of BH resources by educating partners, leading trainings and workshops that targeted BH providers, county leaders, and the faith community on culturally relevant and appropriate strategies. 3) Coalition & Network: Brought groups and individuals together to obtained broader goals and greater impact on improving the mental health of East African young men and boys: African Advisory Committee for Mental Health, Mind Your Health Steering Committee, providers, community partners, and faith leaders. 4) training workshops and skills building events/activities are provided. Finally, we have 100 youth participants.
