Bozeman Health Medical Group employs physicians under the Bozeman Health system umbrella. This group of providers compassionately serves the patients of Bozeman Health Deaconess Hospital, Big Sky Medical Center and Bozeman Health Urgent Care.

Form 990, Part III, Line 4b:

In efforts to reach our community and surrounding area in multiple facets of healthcare, the Bozeman Health system operates additional healthcare facilities which allows more access and levels of care Big Sky Medical Center had 33 admissions, 13 surgeries and saw over 3,700 patients in the Emergency Room and over 5,100 in the clinic in 2018. The net revenue yield on these operations was only 60.2%, or \$486 per equivalent ER visit. With challenging core staffing and related costs, the operating expense (excluding interest, taxes and depreciation) was \$816 per equivalent ER visit. This resulted in a \$5.2M operating loss for the year. Bozeman Health is committed to providing access and patient care to the Big Sky community in spite of the financial operational challenges the facility continues to face. Bozeman Health also continues to operate our Main Street Urgent Care as an outpatient healthcare access point. With a 51% yield on \$4.4M of patient charges and operating costs of \$3M, the Urgent Care netted a loss of (\$660k) in 2018.

Form 990, Part III, Line 4c:

Bozeman Health serves as the parent company of the Bozeman Health system. As the corporate parent, management, general and administrative services are centralized here and provided to the operating units caring for our patients. These administrative and support services aim to optimize executive, organizational and financial responsibilities to allow the health system to continue to grow and serve the population. In this past year, Bozeman Health had 19,383 inpatient days, 200,521 outpatient hospital visits, 260,855 outpatient clinic visits, 35,059 emergency room visits and performed 9,103 surgeries.

Upon request, patients may be asked to complete an application for Medicaid participation or for coverage by other governmental payment programs. 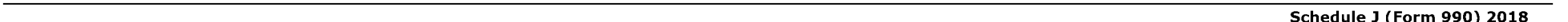
