Reasonable Cause Statement

Melita Christian Fellowship Hospital Aid Plan (“Melita”) had reasonable cause for its failure to timely file its Form 990 for tax year 2018. Therefore, Melita kindly requests that the Service accept the enclosed late Form 990 for 2018 without penalty.

1. Procedural Background

Melita is an Arizona nonprofit corporation. It is organized as a health care sharing ministry that provides an alternative way to fund its members’ health care costs while protecting and practicing Catholic beliefs. More specifically, Melita seeks to restore and rebuild an authentic Catholic health care system that respects and promotes the church’s teachings and traditions regarding love, responsibility, and the sanctity of human life while endeavoring the share the eligible medical expenses of its members.

Melita is recognized as tax-exempt under Internal Revenue Code section 501(c)(3) and as an integrated auxiliary of a church. As an integrated auxiliary of a church, Melita is not required to file a Form 990. Thus, Melita has elected to file a Form 990 in the interest of promoting transparency rather than as a matter of legal obligation. Melita has never before failed to timely file its Form 990. This is a first-time omission.

2. Melita had Reasonable Cause with Respect to its Failure to File Form 990 in tax year 2018 and Acted Swiftly to Correct the Cause of the Reporting Failure

Melita uses the calendar year as its fiscal year. Melita’s 2018 Form 990 was due, after extension, on November 15, 2019. Three weeks before Melita’s 2018 Form 990 was due, its chief financial officer resigned. In connection with his resignation, Melita’s board and senior officers learned that the then-resigned chief financial officer had failed to reconcile and close Melita’s books for the 2018 fiscal year and had not completed a draft of the Form 990.

Melita’s board and senior officers then moved quickly to hire an interim chief financial officer. An interim chief financial officer was retained a few weeks later and promptly began working to reconcile and close Melita’s books for 2018. Melita had grown significantly in size during the 2018 fiscal year and its rapid growth required the organization to adopt new accounting processes and systems. In January 2020, Melita’s interim chief financial officer completed his work on the 2018 books and delivered a report to Melita’s outside accountant containing the financial information she needed to complete the 2018 Form 990. She immediately began preparing the 2018 Form 990, which she delivered to Melita in late April.

In addition to retaining a new chief financial officer, Melita also engaged a lawyer who specializes in advising nonprofit organizations to help it establish governance policies and procedures designed to prevent these delays from occurring again. Upon the advice of its legal counsel, Melita has also developed a filing calendar and internal controls designed to ensure that multiple officers and staff members will be responsible for the timely completion of future Form 990 filings.

Given that the failure to timely file was the result of the untimely resignation of Melita's chief financial officer, and Melita has taken appropriate steps to establish procedural safeguards to prevent a late filing from occurring again in the future, Melita respectfully requests that you abate any penalties resulting from the late filing of the 2018 Form 990 for reasonable cause.

3. Requested Relief

Considering the facts set forth above, Melita respectfully requests that the Service make the following determinations with respect to its Reasonable Cause Statement:

1. Melita has satisfied the requirements of establishing reasonable cause for failure to file its 2018 Form 990;
2. Melita will not be subject to penalties under § 6652(c) for failure to file its 2018 Form 990; and
3. Melita will maintain its tax-exemption status.


