International FIRST Committee Association, FIRST Global, makes grants to organizations outside of the United States exclusively for the purpose of allowing teams of students, particularly from disadvantaged countries, to participate in the FIRST Global Challenge. Each grant was made via a credit card, held by FIRST Global, for robotic kit parts and some air travel and some local accommodations for teams to participate in the event. FIRST Global monitors the use of grant funds by observing the actual funded event and confirming all teams receiving grants are participating.

Grants and event costs are reported at the amount expended. Travel expenses are reported at actual cost.

The 2018 FIRST Global Challenge was held in Mexico City, Mexico. FIRST Global partnered with a company in Mexico to pay the vendors and associated fees of hosting the event. These services were performed at no cost to FIRST Global. FIRST Global monitored the use of funds by setting an agreed upon budget and reviewing each invoice.

International FIRST Committee Association, holding competitions as FIRST Global, is a non-profit organization established to excite the youth and nations of the world about the value of investing in and pursuing STEM education (Science, Technology, Engineering and Mathematics) to help build the science, engineering, and technology skills needed by nations to work on global challenges together. Driven by the enthusiasm of the students as they cooperate in teams, each nation is invited to assemble their own robot and send a high school student-team to represent its country in an annual international olympics-style robotics competition.

The mission of FIRST Global is to enhance the global call for STEM education in the international student community. FIRST Global does so by combining the excitement of sport through robotic challenges with the rigors of science and technology, while emphasizing the value of nations' cooperation in addressing the Grand Challenges of Engineering, as identified by the National Academy of Engineering of the United States, that our planet and people must tackle in order to thrive.

Because of this, the collaborative character of leadership brought out in international youth by this effort is a defining basis of FIRST Global's success.

Form 990, Part III, Line 4a - Program Service Accomplishments

In August 2018, the FIRST Global Challenge was hosted in Mexico City, Mexico. An olympic-style competition, the 2018 games hosted teams from 185 countries, plus several continental teams. Each team is allowed a maximum of 7 student competitors to attend the event with an unlimited number of team members allowed to work on the challenge in their home country in preparation for the event. Under the guidance of volunteer mentors, approximately 2,530 high school students attended the event. In

preparation for the 2018 FIRST Global Challenge, over 1,250 volunteers actively mentored participants. These community-based volunteers range from civic minded high school and college students, to entire university robotics and engineering departments, and provided teams with mechanical, electrical, programming, and strategic advice. First Global collaborated with TV Azteca SAB de CV, who served as the host of the FIRST Global Challenge 2018 Mexico City.
