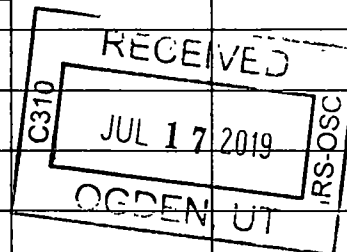

On January 25, 2019, it was discovered that a significant diversion of assets occurred in the bank account of this organization. The former treasurer obtained unauthorized loans without the knowledge or consent of the other board members. The former treasurer also presented falsified meeting minutes showing a fabricated election resulting in a new (made up) board of directors. In addition, fraudulent Corporate Resolutions to Borrow were given to the bank with forged signatures of these fabricated, new board members. This activity began in September, 2015 and continued until the activity was discovered on January 25, 2019. Upon this discovery, the remaining board members voted to immediately remove the treasurer from the board and appoint a new, interim treasurer to complete the school year. In addition, the board canceled the debit/VISA bank card and ceased all banking activity in their bank account. They moved their banking to a new bank and opened a new account. This account requires two officer signatures on every check, board approval for any changes to the account and requires every board member to have access to the online banking system. Also, the treasurer is to provide membership with a copy of the bank statement at each monthly meeting and an independent audit of the account will be performed annually. Unauthorized loans obtained through the bank were \$25,633 in 2018.
