At SHO-Uganda we are working with the team to create a self-sustaining primary school / orphanage where they are able to feed and clothe orphans/needy children. The program at this time is able to fully support 200 children between the funds that we are able to provide and the funds that they get from other day schoolers and boarding students. (Each term varies but there is anywhere between 150 and 200 additional students that attend the SHO-Uganda school). The school total enrollment is on average 350 students between those that are in need and the paying students. II Education program (1) Education is a key to the success of the project growing and becoming self-sustaining. Shared Hope for Orphans Worldwide (SHOW) was able to provide \$23,311.37 for education. These funds came from random donors throughout the year and the monthly sponsorship program. With these funds we were able to help educate 350 students from pre-school through about 7th grade (P7 by Ugandan education levels). The program at this time is able to support 200 orphan / needy children and each term varies but there is anywhere between 150 and 200 additional paying students that attend the SHO-Uganda school. The school total enrollment is on average 350 students between those that are in need and the paying students. SHOW is also using education funds to purchase needed books and supplies. III Community Development program (1) In 2018, SHOW was able to provide \$32,087.00 in funds for community development. One major thing that SHOW is doing in this area is walking step by step, with the SHO-Uganda staff, thru income generating projects. By doing this we are empowering the people so that they are better able to budget for new projects and create increased incomes because they are able to learn business management. (2) The 2018 year has been about to bring many changes to the groups and community around SHO-Uganda. SHO-Uganda and SHOW were about to partner and build a much-needed Guesthouse for international visitors. Security is always a high priority, so we were able to build a gate house for the protection of the children, staff and visitors. SHO-Uganda also started the construction of an office/ nurse's station that we hope to have completed in 2019. Other things that were added in 2018 are that SHO-Uganda was able to move from a pit latrine to having urinals.
