The Nebraska City Veteran's Memorial Building Project is dedicated to the renovation of the exterior of the Nebraska City Veteran's Memorial Building to re-establish a space for cultural, educational and recreational activities in the southeast Nebraska, and southwest Iowa region. The building, dedicated originally in 1929 to World War I and Spanish American War veterans, was emptied and closed in 2007. The Project assisted in the replacement of an area of roof that had been leaking for several years and painted the related soffit. Air conditioning units were disengaged and moved for the installation of the new roofing.

4b (Code) (Expenses \$ 2,500.00 including grants of \$ 0) (Revenue \$ 0)

The Nebraska City Veteran's Memorial Building Project is dedicated to the renovation of the interior of the Nebraska City Veteran's Memorial Building to provide space for cultural, educational and recreational activities that will provide ongoing funding to sustain the building into the future. The interior of the 1929 building was stripped of all furnishings and nearly all fixtures when it was closed in 2007. The Project accomplished cleaning of floors and woodwork, replacing ceiling tiles and lights, and painting in the lower level. Safety equipment such as exit signs and fire extinguishers were replaced.

4c (Code) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)

The Nebraska City Veteran's Memorial Building Project is committed to bringing the historic Nebraska City Veteran's Memorial Building back to its original use as a space for military veterans and community activities. Although the project is early in its plans to renovate and revitalize the building, there were limited events in two areas of the building. Five times during the year the main level was open for the public to visit displays of military veterans who lived in the local area. Veterans displays included those who fought in World War I, World War II, Korean War, Vietnam War, and Desert Storm and also included a large display of war memorabilia. These openings covered 10 days with other openings based on appointment. Later in the year, the lower level held two holiday farmer's market events.
