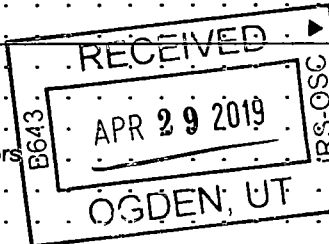

bowling tournament. No net revenue was realized but there is additional inventory left over that will be sold in the future for additional funds.
