

Rwanda Ministry Partners is organized exclusively for religious, charitable, and educational purposes. Including, for such purposes, the making of distributions to organizations that qualify as exempt organizations, described under 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code. Specifically, it has as it's purpose promoting personal and community transformation through sister church and diocesan relationships between Anglican Church of North America (ACNA) and the Anglican Church of Rwanda (ACR or EAR(french)). To this end, Rwanda Ministry Partners recruits, provides training for, and facilitates all aspects of sister church relationship developmnets. Additionally, it raises funds for relief and/or development projects carried out by the Anglican Church of Rwanda and the Anglican Church of North America to benefit and improve the lives and communities of the people of Rwanda.

Other Program Services- Other than those listed on lines 28,29,and 30.

A \$5000 grant was sent to Anglican Church of Rwanda Provencial Office (the church's national headquarters) for Accountability and Stewardship Project. Additional funds were to embrace Rwanda for other projects throughout Rwanda. \$4916 was sent to Kigeme Diocese for projects \$2000 Shyogwe Diocese for projects. \$2600 was sent for church improvement projects to stop closure of churches because of physical property problems.

Other Notes

Additional 2018: \$92,937.92 was received from Dioceses of the Angican Church in North America (ACNA) to be a direct flow through to the Anglican Church of Rwanda (ACR). Funds were accumulated to save wire fee charges in transmitting the money. No income was derived from these fund received. \$88,411 74 was transmitted in 2018 and the remainder have been transmitted in 2019 due to the end of year banking issues. Bank Wire Fees were taken from these funds.

Note Total Liabilities YE 2018 Liabilities reported \$7,825 was from funds received in December 2018, and not disbursed until January 2019 due to holidays and bank closures at the end of 2018.
