Hands-on, interactive programs were presented in collaboration with local nonprofit organizations, schools, libraries, Boys and Girls Clubs, with a focus on access for all ages, physical and emotional abilities, and socioeconomic status. EXHIBITS kidSTREAM secured terms to purchase and a lease agreement for the former Camarillo Library building in June, 2018. With a grant from VCCF combined with in-kind gifts from local businesses and board director cash gifts, the community room and front patio were transformed into a mini childrens museum called the Vision Room. Dozens of indoor and outdoor hands-on, minds-on exhibits include the wall-sized Amazing Airways, the Flight Lab, engineering gear wall, Light and Dark room, puppet theatre, imaginative play campsite, creative light tables, interactive water play, clay bar, a giant erector-set-like Rigamagig, floating sensory pods, fishing village, and more. These exhibits inspire children and their adults to engage together in experiential, sensory-based learning.

ON-SITE PROGRAMMING AND EVENTS Beginning in August, 2018, kidSTREAM supplemented its regional outreach with on-site educational programming and events for children, families, and teachers. Experiences and activities encouraged open ended exploration, where exciting discoveries were made in the arenas of STEM, Arts and Reading that changed the trajectories of many lives. An early investor in kidSTREAM, Autism Society Ventura County became an advisor, mentor and guide towards designing exhibits, environments, and activities that are sensory friendly with access for all. While kidSTREAM raises funds to purchase, renovate and transform the building that sits on two acres in the heart of Camarillo, with 30,000 feet of indoor and outdoor hands-on exhibits and interactive galleries, the Vision Room is open on select days for scheduled events and educational programming.
