

 Dr. Nancy Speck at the University of Pennsylvania is developing a mouse model of RUNX1-FPD by introducing mutations into the RUNX1 gene that lower the effective RUNX1 dosage in the mouse. She proposes to use this model to test which secondary mutations found in MDS and AML are the most potent at driving clonal hematopoietic stem cell expansion and leukemia in the context of lower levels of RUNX1 activity. This study will complement the planned longitudinal natural history study of RUNX1-FPD patients that the RRP is launching with the NIH in the spring. Knowing which acquired mutations behave most aggressively to promote hematopoietic stem cell expansion and leukemia will help physicians decide how early to intervene if a patient has evidence of clonal hematopoiesis. The RUNX1-FPD mouse model will be made available to other investigators who wish to test the activity of drugs to delay, prevent, or reverse clonal hematopoietic stem cell expansion associated with acquired mutations. This mouse model will be an essential tool for the pre-clinical development of any therapy prior to a first-in-human clinical trial in RUNX1-FPD patients.

4b (Code:) (Expenses \$ 190,500 including grants of \$ 90,500) (Revenue \$ 0)
 Several research groups around the world have leveraged genetic sequencing technology to uncover the somatic mutations associated with the development of malignancies in germline RUNX1 mutation carriers. Collectively, genetic sequencing information can lead to powerful insights that are essential to applying precision-based medicine. Such information may have utility at diagnosis, for risk stratification, for effective monitoring, and ultimately in treatment decision-making. Dr. Brown, Prof. Scott, and their team at the Centre for Cancer Biology at the University of South Australia are leading a project to generate a data-sharing platform for investigators around the globe to contribute and share germline and somatic genomic sequencing data generated from RUNX1-FPD individuals. They will create a custom-designed web portal for RUNX1 genomics data and then allow investigators from around the world to deposit data individually in this central location, which can be viewed and queried as a single cohort. Generating a RUNX1 world genomics cohort through data aggregation will attempt to address many of the unanswered genetic and pathophysiologic questions. The database will provide a robust resource that continues to grow with ongoing sequencing efforts.

 Dr. Ebert will study the cooperation between mutations in RUNX1 and in a gene encoding a member of the cohesin complex, STAG2. RUNX1 and STAG2 are commonly co-mutated in MDS and secondary AML patients. He plans to generate a mouse model for the combined RUNX1 and STAG2 mutations and study hematopoiesis and leukemia progression. Dr. Ebert will also evaluate inhibitors of CDK8, a member of the transcriptional mediator complex, for their activity and mechanism of action in the context of RUNX1 and/or STAG2 mutations.


