Safe House - The safe house was established in response to a need for vocational training for rescued sex workers, to provide an alternative for women desiring to leave the work of the brothels. Each resident receives counseling and vocational training, as well as the opportunity to study traditional school subjects, while learning other life skills.

4b (Code:) (Expenses \$ 23,294 including grants of \$ 22,250) (Revenue \$)
Children's Homes - Two children's homes are supported in part by donations from Restoring Hope Nepal. These homes provide care and education for orphaned children in Nepal.

4c (Code:) (Expenses \$ 15,932 including grants of \$) (Revenue \$)
Missions Trips - A key part of raising awareness for the ministry and its needs is through facilitating short-term mission teams into Nepal. A secondary purpose of the team is to take in supplies in the forms of goods and money for the day-to-day operation of the homes. All team members raise their own support, so that no donor funds are taken from the general pool.

The majority of disbursements are made in person by representatives of the organization, who visually confirm that funds are being used for their stated purpose. The organization in Nepal submits a budget that itemizes expense categories, which are verified with current market costs. Dual sign-offs are maintained for disbursement of cash funds from the organization's representative to the receiving organization in Nepal. Other receipts and documentation are not available in this cash-prominent economic system. Requests for additional funds are measured against current funding levels, which are adjusted as necessary based upon growing needs (and number of residents).
