St. Nicholas Charities has one Program Service: Charitable Housing. Specifically, the purpose of this program is to provide shelter to indigent or afflicted persons who practice the Orthodox Christian faith. All labor is on a volunteer basis and therefore there are no salaries, director, officer, or payroll expenses. The total expenses incurred for this program primarily relate to paying the utilities on these residential properties, as itemized below in the Statement of Functional Expenses in Part IX of this form. Total program expenses for 2018 came to about \$12,200 over the annual budget amount of about \$20,000 per year, primarily due to an increase in electric expenses (\$5,800 over budget), Housing Association Fees/Dues (\$4,700 increase over budget), and insurance (\$2,000 increase over budget). This was offset by a favorable variance of \$0 repair and maintenance expenses for the year. There were no cash donation during the year. Total in-kind (non-cash) contributions related to the payment of utility expenses for some of the residential properties paid by the 501(c)(3) organization that St. Nicholas Charities supports as a Type-1 509(a)(3) organization.
