In addition, we interacted with a handful of White House, DoD, and DoE officials to advise on what became the President's Executive Order on Coordinating National Resilience to Electromagnetic Pulses (March 26th, 2019). Some funds were spent to pay for staff time and travel costs associated with these meetings. The total was a diminutive portion of our overall staff time and resources.
