



**EXPLANATORY BASIS FOR PREPARING THE MONUMENT IN HELENA, ARKANSAS**

THE ELAINE MASSACRE MEMORIAL COMMITTEE WAS FORMED TO MEMORIALIZE THE VICTIMS - KNOWN AND  
UNKNOWN - MURDERED IN PHILLIPS COUNTY ARKANSAS LATE SEPTEMBER AND EARLY OCTOBER 1919 BY  
LOCAL POSSES AND THE U.S. ARMY. LITTLE KNOWN EVEN IN PHILLIPS COUNTY, IT IS PROBABLE THAT  
THE MASSACRE WAS THE LARGEST LOSS OF LIFE IN BLACK-WHITE RACIAL CONFLICT IN THE COUNTRY'S  
HISTORY. THE MEMORIAL WAS DEDICATED IN FRONT OF A CROWD OF FIVE HUNDRED PEOPLE ON  
SEPTEMBER 19, 2019, EXACTLY ONE HUNDRED YEARS AFTER THE MASSACRE.
