

PROTECTION OF WILDLIFE IN KENYA. THE RHINO SANCTUARY IS HOME TO 14  
BLACK RHINOS UNDER INTENSE ANTI-POACHING SURVEILLANCE WITH A RECORD OF  
ZERO POACHING. OUR FUNDS WENT TOWARDS FUEL FOR AIRCRAFT FOR AIR  
SURVEILLANCE PATROLS OVER THE AREA AND MILK FORMULA FOR BLACK RHINO  
CALF, LOLIJIPU, WHO NEEDED TO BE FLOWN IN TO THIS REMOTE AREA. 3) CARE  
FOR WILD RHINO SANCTUARY, SOUTH AFRICA \$2,500 - THE COC FUNDED A SAFE  
HEATING SYSTEM TO BE INSTALLED IN 5 SLEEPING BOMAS FOR YOUNG ORPHAN  
CALVES. SOUTH AFRICAN WINTERS GET VERY COLD AND SMALL RHINOS ARE VERY  
PRONE TO GETTING SICK. \$500 WENT TOWARDS HELPING FUND AN EXTRA DAY OF  
A HELICOPTER & PILOT IN AN URGENT RESCUE MISSION TO FIND A CALF WHO  
HAD BEEN ON IT'S OWN IN THE BUSH FOR OVER A WEEK AFTER ITS MOTHER WAS  
POACHED. THE CALF WAS VULNERABLE TO PREDATORS AND DEHYDRATION. SHE WAS  
FOUND AND BROUGHT TO CFWRs WHERE SHE STILL RECEIVES EXPERT CARE.
