OUR THREE LARGEST PROGRAMS IN 2018 AND THEIR EXPENSES:

1) Since January 2014, we have been developing English libraries at public high schools in under-resourced rural communities of Morocco.

These are primarily Amazigh communities in the mountains and desert areas that have not had libraries or other educational enrichment

of this kind in the past. In 2018, we developed 10 class libraries in partnership with Rotary International and began work on a network of 17

libraries in the Zagora region in partnership with the US Embassy in Morocco. We also launched a program called Environmental

Changemakers at 3 of the schools, to study climate change and plastics pollution. One of the schools in the environmental program

is also connected to a high school in California for a virtual exchange of learning. Together, these programs will provide resources to an

estimated 18,000 students. (\$22,709)

2) We partner with a community-led conservation education nonprofit in Talek, Kenya, called Friends of Maasai Mara (FOMM). In 2018, we

found donors to purchase land on the edge of the Maasai Mara National Reserve for a conservation center, for both the community and

visitors who come from around the world to witness the local wildlife. We also supported the purchase of a platform tent for the first

interpretive center and supplied materials including a sound system for FOMM's after-school program teaching students about conservation.

This program is expected to impact 5,000 students at local schools. (\$33,642)

3) We began work on a library for the Mara Girls Leadership School in Talek, Kenya. This is an extraordinary private middle school for girls

from across the Maasai Mara region who are talented and motivated but are from families who would otherwise not have the means to send

them to school. This was just the beginning of a comprehensive library, and further work is ongoing in 2019. This program has a direct

impact on the 48 students at this school and when finished will also impact the 1100 students at the public primary school next door,

as the library will be open to them as well in 2019. (\$960)
