<p><b>28</b>                      Wildfire provided Network Services to launch and expand 12 startup ministries. At the end of 2017, Wildfire served 3 ministries but grew to include 12 over the course of 2018. We provided these ministries with free financial, administrative, coaching, training, and media services worth a real world value of around \$60,000. Financial services consists of bookkeeping, donor processing, documentation keeping, and financial coaching. Of the networks 12 ministries that it helps support, 5 of them utilized this service. Through our administrative services, by agreeing to further the nonprofit purposes of the Wildfire Network in accordance with our corporate values, the network of ministries is able to operate under the umbrella of legal nonprofit covering provided by the Wildfire Network. All 12 ministries receive coaching monthly, with more frequent coaching upon need or startup. The coaching platform provides guidance, mentoring, and counsel for all aspects of ministry development. Over the course of 2018, Wildfire lead 3 training conferences along with a separate training course for ministry leaders. Our media platform provides assistance with graphic arts, web design and management, and social media consultation. All of the 12 ministries that Wildfire serves utilized free media services during 2018. In order to provide these free services, Wildfire incurred related expenses of \$67,403.
