28 Currently the choir members are split fairly evenly in 3 cohorts Homeless members living in cars, shelters or on the streets Housing-insecure members living in subsidized or supportive housing Supporting members Participants who are not in the above categories who provide emotional, financial, material or volunteer support Supporting members provide a critical bridge to our recovering members They do not receive any material support from our case management or our other supportive programs From the beginning our program has focused on providing a safe place for the unsheltered to meet and be uplifted through music From a health perspective, the power of music making and performance addresses several aspects of health inequalities and the social determinants of health and wellbeing Music participation is a transformative tool to positively impact wider social, cultural and environmental conditions We see that tool at work every week Over time, entirely from the efforts of a largely volunteer staff, performance fees and private fiscal support, we have organically expanded our services to include the following programs Weekly Rehearsal The choir program serves as our primary outreach and recovery program Through music we invite and retain our members providing a beacon of light Each week we serve a nutritionally balanced, healthy meal Performances Our members receive an unequalled emotional benefit from performing live in front of an audience Performing, among many things, improves self-perception, self-confidence, and a members ability to make and fulfill a structured commitment Choir Care Homeless and housing-insecure individuals are offered free case management to acquire and maintain safe shelter Guitar and Songwriting Lessons Prior to our weekly rehearsal we offer free guitar lessons and songwriting classes for our members Food Distributions We provide weekly nutritional support to our members and the surrounding community Advocacy Choir members are trained and organized to speak on behalf of our at risk and unsheltered populations Singing provides a positive sense of community and solidarity for people facing extreme hardships Our core choral program reduces stress, heightens awareness, empowers minds, strengthens bodies and sets the stage for peace and healing WEEKLY REHEARSAL Voices of Our City Choir program meets every Friday morning in space rented from the Living Water Church of the Nazarene at 1550 Market St in downtown San Diego and performs frequently at venues throughout Southern California The choir is the anchor of the organization and draws participants from across the county Membership in the choir is open to all people, however, services are not Once new housing-insecure or unsheltered participants have experienced the sense of support and community offered by the choir, they can become a member and receive individual case management services We then identify the persons needs and create a plan that will lead to self-sufficiency As that plan is executed, volunteers and the few paid staff members work to connect the member with services, housing and/or employment Once housing and/or employment are secured, VOOCC provides support including food, household items transportation, training, and other services to help the formerly homeless person maintain their new status PERFORMANCES Performances serve 3 roles Performances build the confidence of our members, they are our primary form of outreach, and they change the perceptions of the unsheltered among our sheltered neighbors We have found that the benefits of performing with the choir are significant, Performing builds pride, confidence and organizational skills such as time commitment and planning The choir also generates revenue to cover some of its operating costs from certain higher priced engagements Over the Last two years the choir generated 50% of its revenue from performance fees and contributions from our audience CHOIR CARE Individuals attending choir practice with immediate, critical housing needs will receive supportive services at that moment to obtain shelter After attending 4 rehearsals our Choir care team (Case Management) becomes available to all unsheltered and housing-insecure members Our choir care team provides material support to members who desire to get off the streets as well as members that are recently housed and members that are housing-insecure The team also provides outside referrals for crisis management and health services among many others WORKSHOP The choir provides quarterly workshops that focus on personal development, financial management and personal health These workshops assist our members to continue their recovery and build a stable foundations for their lives moving forward We continue to receive positive feedback on these programs from our members but the key determinant of their success is the ongoing member participation in these programs FOOD DISTRIBUTION Many of our members are food-insecure and our nutritional support program provides healthy staples such as rice, grain, meat, fruits and vegetables as well as canned and dry goods This program is available to choir members as well as anyone from the local community every Friday We deliver at least 4 meals per participant weekly ADVOCACY From the very beginning we have encouraged our members to participate in the political process by representing the needs of the unsheltered community in front of governmental and quasi-governmental agencies across the county Each year our members have been present in at least 25 different public meetings and have been covered in numerous press outlets of all types By representing the housing-insecure and unsheltered, our members gain a stronger sense of self and act as ombudsmen among the homeless community In 2018 we also hosted the City Council Candidate Forum on Homelessness and in 2019 we are planning a Mayoral Candidate Forum INTERIM SHELTER Thanks to the support of generous donors the choir has been able to stabilize members in a housing crisis in hotels or at the residence of one of our supporters until such time that we can get them into an appropriate longer term shelter or program This interim shelter has been a critical component in the placement of over 20 of our members The accomplishments of the Voices of Our City Choir to date include We have grown to over 150 active choir members 38 unsheltered singers have transitioned from unsheltered to safe shelter and/or their own housing 400 healthy meals are provided weekly to choir members via our nutritional support program 80 people, on average, participate in the Friday morning rehearsals and music workshops VOOCC served 2600+ lunches in 2018 VOOCC staff (paid and volunteer) support unsheltered members with case management, clothing, food, transportation and connections to health services VOOCC actively advocates for the decriminalization of homelessness, combats NIMBYism, and supports immediate housing solutions VOOCC has become an in-demand performance ensemble, with an active concert calendar, which generates almost half of the operating budget (approximately \$7,500 a month) The remainder of the budget comes from donations VOOCC performed over 120 concerts including performing with The San Diego Symphony and the Master Chorale over Labor Day weekend VOOCC hosted the City Council Candidate Forum on homelessness The Voices of Our City Choir was the subject of an award-winning documentary film from Susan Polis Schutz which was broadcast over 90% of America on PBS television The film received rave reviews from the Emmys com, the LA Times, and the Village Voice in New York Press coverage both locally and Nationally including Voice of San Diego, San Diego Union Tribune, NBC 7, KPBS, PBS Newshour, The Huffington Post, The Emmys and many others Awards San Diego Voice of the Year 2018, Christie Awards for Broadcasting - New York, Considered for an Emmy Nomination 2018 (Grants \$ 120,597)	28a
