Following the Money Upon request from local community advocates, our researchers map and analyse the investment and supply chains of harmful investment projects, identify points of leverage, and provide strategic advice on advocacy In 2018, we produced in depth investment chain mapping analyses on 35 harmful projects around the world, including in Guinea, Senegal, Liberia, Kenya, Uganda, Laos, Vietnam, Cambodia, and Palestine Through our research, we discovered approximately 15 new opportunities for affected communities to file complaints to international accountability mechanisms This year, partners in Kenya, Liberia, Democratic Republic of Congo, Uganda, the Philippines, Guinea, and Cambodia took steps to pursue advocacy strategies based on our investment chain analysis and advice

Case work In certain high-impact cases, we provide advocacy support and accompaniment to communities and their local partners. Depending on the case, we may assist in collecting evidence, filing complaints to accountability mechanisms and courts, engaging in negotiations with companies, and conducting media and investor advocacy. In other cases, we provide "light touch" assistance to help guide local partners to engage in international advocacy. In 2018, we supported communities and local partners to implement their advocacy strategies in eleven cases in Africa and Asia. In seven of these, in Guinea, DRC, Myanmar, and Cambodia, we provided full accompaniment. In four others, in DRC, Liberia, Uganda, and the Philippines, we provided lighter touch support. Highlights include -----Supporting a community in Guinea that was forcibly displaced to make way for an open-pit gold mine to seek redress. This included intensive negotiation training, advocacy with investors, and accompaniment of the community in nearly 100 hours of mediation meetings with the company. -----Training 13 rural communities in Guinea whose farmland and water resources have been destroyed by one of the world's largest bauxite mines on the environmental and social standards that the mining company is contractually required to respect and conducting extensive consultations and impact assessments to build a complaint to an international accountability mechanism. -----Supporting 12 indigenous villages in Cambodia, whose ancestral lands were seized by a rubber company, through intensive mediation and land demarcation processes aimed at resolving the conflict. -----Assisting more than 700 Cambodian families who were forcibly displaced by a Thai sugar company to file a pioneering extra-territorial class-action lawsuit, opening up a promising legal front in a decade-long struggle for remedy of one of Cambodia's most egregious land grabs. -----A planned coalmine in Myanmar was suspended as a result of local opposition and international advocacy, including a complaint to the Thai Human Rights Commission filed with the support of Inclusive Development International. If fully developed, the mine, backed by Thai investors, would have threatened the land and resources of thousands of local people. The suspension marked a huge victory for the affected communities.

Policy advocacy We advocate at the global, regional and institutional level for stronger standards and accountability mechanisms governing business and development-related human rights and environmental harms In 2018, we continued to lead civil society efforts to reform the International Finance Corporation's opaque and unaccountable financial intermediary lending strategy, worth some \$57 billion Through our campaign, we tracked and exposed how many of these "development" dollars end up in harmful projects with debilitating impacts on communities Our advocacy has already begun to change the way the IFC does business, with catalytic effects on the financial sector In 2018, the IFC committed to drastically reduce its exposure to the coal industry and rights-abusing corporations by targeting the vast majority of its lending towards projects with genuine development outcomes It also committed to coaxing commercial banking clients to stop financing coal, through financial incentives Other accomplishments include the adoption by the Asian Infrastructure Investment Bank of its Complaint Handling Mechanism policy, which incorporated several recommendations that we advocated for along with coalition partners
