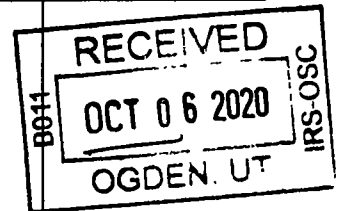

In August of this 2020, I received a notice from the IRS saying that our tax-exempt status was automatically revoked due to not filing an annual 990 for three consecutive years (we began in late 2017 so 2019 would be the third year in which a filing was required). We are a small organization with limited funds and I've tried to save money by doing all of my own accounting, payroll and taxes. I thought my software, Quickbooks Online, was notifying me of all forms I needed to file. I confused the requirement for a 990 with the quarterly 940 forms I was sending. Upon receiving this notice of delinquency, I immediately filed a Form 1023 to reinstate our 501(c)(3) status and began working on these past three years of 990-ez forms, including this one for 2019. I will, of course, file these required forms on time from now on.
