Makerspace. Classes can teach the basic skills of a machine, tool, software, or process but only practical experience can hone those skills so that they are truly useful.
Our makerspace is stocked with a range of tools both simple and complex: from hammers to CNC laser cutters.
Makerspace members pay a monthly fee to gain access to all the tools we have in stock.
Our experienced staff maintains the machines in excellent working order and are always available to lend a hand or provide a bit of advice on how to effectively use a tool. Makerspace members use our space to create anything they can imagine.

Youth Classes. Science, technology, engineering and mathematics (STEM) workers play a key role in the sustained growth and stability of the U.S. economy, and are a critical component to helping the world thrive the future.
STEM education creates critical thinkers, increases science literacy, and enables the next generation of innovators
Innovation leads to new products and processes that sustain our economy.
Our STEM classes include Art and are known as STEAM education. We provide 5-day camps for youths in grades 3 through 12. We provide short programs that help Scouts (Boy and Girl Scouts) to earn maker-related badges. We also offer resources to the home schoolers in our community.

Adult Classes. Many adults have ideas for new devices, products, or artistic expression. Sometimes these ideas solve a local problem; sometimes they are world changing. Sometimes the ideas just add to the overall enjoyment of the community.
Realizing these ideas requires using tools and software that many people have no experience with.
We offer classes from the basics of using a table saw or soldering iron, to the use of 3D modeling software and laser cutters.
Our classes help both the beginner and the skilled artisan. Everyone is welcome to improve their skill set in our classes.
Once they have the skills, these makers might become a makerspace member to continue improving their skills.
