Proceeds are generated through registration of cars, sponsorships for awards and sponsorships towards administration costs for which individuals or companies receive recognition by printing logos on programs, flyers, etc, vendor sponsorships which provide them space at the event to sell or promote their war and through the sale of beverages and clothing such as caps and T-shirts. A portion of the proceeds are paid to charitable organizations.
