

After each parade if possible rides are given while volunteers share information about the services provided. Also donations may be received for the center.

This first season we were in 7 parades. Also the train was used 8 times for rides. 680 different children were given rides. Hard to estimate parade spectators. But would say 30-40 thousand people saw us.

The train and equipment were created by me using used lawnmower parts. All beginning materials were donated by me. Some expense outside of ongoing expense fuel-tires-printing-signs, was to upgrade and improve the equipment.

I plan to sell some used planes using the funds to increase our grants to the center.
