The Leadership Academy program was established as a one-year fellowship for each student that would require them to work on a project specific to their campus or community. The program would also include one-year mentorship, a regional training academy and participation in the ARHE National Conference.

In order to address the stigma associated with addiction, SAFE Project has established a Speaker's Bureau (SAFE choices) program to go into secondary and post-secondary schools and talk to students and their parents about addiction, the science of addiction and the susceptibility to the disease. The goal of these programs is to provide students with tangible information to be aware of the risks and also to be willing to assist a student in trouble. Additionally, the program is also created to alert parents of the risks and signs of this disease. The SAFE Choices program has been presented at numerous schools throughout the country. The program has been presented in groups as small as individual health classes in local high schools to the entire Brigade of Midshipmen at the U.S. Naval Academy.
