REASONABLE CAUSE STATEMENT FOR INITIAL FILING-12/24/18-12/31/18

This reasonable cause statement is being voluntarily and prospectively filed together with the organization's initial Form 990-PF for the short period from 12/24/2018-12/31/2018 year. The organization has not yet received any late filing or deficiency notice.


It was the organization's sincere belief that its initial tax return would be for the 2019 calendar year and not for the short period from 12/24/2018-12/31/2018 because the organization was formed late in December 2018, had no intention to begin operating until 2019 and did not expect to have any activity to report until 2019. It was only when the organization's CPA prepared the 2019 Form 990-PF did it become apparent that the initial contribution to the organization had actually occurred on December 31, 2018 (see attached bank statement referenced as Annex 1) and not January 1, 2019 as the donor had instructed the bank and as the organization's manager had understood to be the case. As a result, this initial Form 990-PF for the short period from 12/24/18-12/31/18 is technically being filed late. We would hope that the IRS could understand that this was an isolated and first instance resulting from an unintentional misunderstanding of the exact date (1 day off) when the organization's initial reporting period began and allow for a waiver of any late penalties regarding this issue. For the 2019 tax year, the organization timely requested an extension to file which was granted by the IRS (Submission Identification Number 65289920201960119752) and the organization timely e-filed its 2019 Form 990-PF on 11/04/2020 (Submission ID 65289920203090004596).

We would also ask that you consider that this organization is essentially a volunteer organization. There are no paid officers nor any paid board of directors. Even the CPA has agreed to assist the organization with its 2019 tax reporting obligations free of charge. Therefore, any penalties assessed against the organization will take funds directly away from the funds used to support the mission of the organization which is focused on providing charitable aid for veterans and orphans. You can see from the small size of the organization that any penalty would have an adverse impact on the ability of the organization to fund its charitable operations.

Finally, as a CPA, I will personally ensure that any future extensions or filings that need to be filed are properly and timely handled. The organization now has a system in place to make sure that any future tax returns are filed on a timely basis. For all of the above reasons, the taxpayer respectfully requests a waiver of any penalties for the late filing of this initial short-period tax return.
