This schooner-based expedition focused on the natural history of the this remote Norwegian Arctic archipelago at the height of the breeding season for seabirds and marine mammals. The diversity and abundance of wildlife--polar bears, arctic foxes, walrus, reindeer, 3 species of seals, and enormous colonies of seabirds--reflects the environmental influences of the warm currents pushed northward by a branch of the Atlantic's mighty Gulf Stream. Global climate change is most dramatic in the Polar regions and participants witnessed firsthand the accelerating impacts of global warming in this remote archipelago just 600 miles from the North Pole
