HIKING, ROCK CLIMBING, BACKPACKING, MOUNTAIN BIKING, KAYAKING, AND WILDERNESS EXPLORATION), PROGRAM OFFERINGS ALSO INCLUDE PERFORMING ARTS AND ARTISTIC ADVENTURES, SCIENCE EXPLORATION, AND GLOBAL AWARENESS AND TRAVEL.

IN 2018, TELLURIDE ACADEMY ENROLLED 828 STUDENTS, AGES 5 TO 17, IN 117 SUMMER PROGRAMS AND 27 AFTER-SCHOOL PROGRAMS RANGING FROM ONE TO SEVEN WEEKS IN LENGTH.
