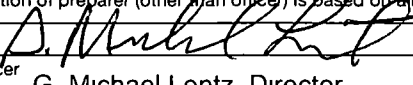

In support of the sport of gay rodeo, IGRA sanctioned 10 gay rodeos and associated activities as well as hosting the World Gay Rodeo Finals in Mesquite, Texas. There were 657 competitors in 5,097 entries for these events. IGRA provided support for three rodeo schools. The IGRA Convention took place in Salt Lake City, Utah in November where rules and standards of competition were reviewed and updated. Four new members were inducted into the IGRA Rodeo Hall of Fame recognizing their lifetime achievements and contributions to gay rodeo. Work continued to build the archives of gay rodeo history, managing the current collection and searching for a permanent home where more of it can be made publicly accessible. The IGRA Royalty Team presented grants to several selected charities in recognition of their on-going contributions to the welfare of the LGBTQ community
