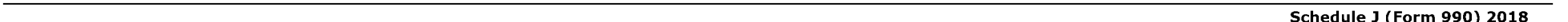

The members of this new committee are the President, Executive Director, Chief Financial Officer, and Chief Operating Officer.

The President and Executive Director were excused from the meeting when their salaries were discussed. Additionally, the President and Executive Director did not vote on their own compensation. The Committee approved the amounts proposed by management and the process used in substantiating the amounts and reported the recommendation to the Board of Directors. The Board unanimously approved the proposed salary.
