Five apartment units are occupied by individuals and families in the low and very low income brackets: currently a family of 7, a family of 2 with a roommate, two couples and one single person. Personal relationships with tenants provide practical and emotional support. Each tenant household is invited to have one member on the Board of Directors, empowering tenants to participate in decisions affecting their lives. Three tenants chose to serve on the Board in 2018. In 2018 we purchased and renovated a four-bedroom house to expand our ministry. Two people lived in this house for the last four months of the year. Our intention is for it to house up to 6 additional people who are currently experiencing homelessness.

Eight is the number of members of the governing body. Only four of these do significantly more work than attending board meetings.

Part VI, Line 8b: There are no committees of the board.

Part VI, Line 11b: No review was or will be conducted.

Part VI, Line 19: None of these documents were made available to the public. They could be made available if there were a request.

Part VII, Line 1a(4)(F): The organization reimburses its administrator/manager for dental and vision expenses up to a limit of \$1,500/year.

Part IX: In 2018 Emmaus Housing purchased and renovated a property to be used for its exempt function. The total cost (land, building and repairs) was \$376,888. There is no associated property debt.

The entire cost was raised within the year. The fund-raising was done by volunteers who contributed their time and out-of-pocket expenses (\$415, mostly for printing and postage).
