

Provide complete video production and post-production services as well as video production training and/or print materials to non-profit corporate clients and individuals seeking educational and training products. We also provide live production services and and visual arts education to non-profit organizations. We regularly serve 5-10 501(c)(3) organizations per year producing content that helps them to generate income, fund raise, spread their message and communicate stories of community impact to the public.

4b (Code:) (Expenses \$ 16693 including grants of \$ 22416) (Revenue \$ 23292)

Provider of video, photo, visual and performance arts education to youth in inner-city and urban areas. We call this the Act Out Theatre program and it includes 14 theatrical performances throughout the community each year. In addition to performance opportunities we provide arts outreach and education in areas of video production, photography, digital media, sound design, scenic design and lighting design. This program impacts approximately 225 local students per year and is attended by approximately 2200 community members each year. The goal of this program is to provide traditionally under-served and under-resourced students in the more urban areas of the community exposure to the arts, opportunities to explore things they have not typically been able to access and positive mentoring relationships with adults who genuinely care about their lives.
