THE LEA COUNTY HUMANE SOCIETY ("LCHS") IS A NON-PROFIT ORGANIZATION AFFILIATED WITH THE HUMANE SOCIETY OF THE UNITED STATES. ESTABLISHED IN 1950, THE LEA COUNTY HUMANE SOCIETY IS A GROUP WORKING FOR THE WELLNESS OF ALL ANIMALS IN LEA COUNTY, NEW MEXICO. A BOARD OF DIRECTORS SETS THE POLICIES AND OVERSEES DAILY OPERATIONS. HEADQUARTERED AT THE HOBBS ANIMAL ADOPTION CENTER, LCHS IS INVOLVED IN DAILY OPERATIONS. ALL FACETS OF ADOPTION, INCLUDING OUTREACH RESCUE PROGRAMMING, INTAKE OF STRAYS, PROVISION OF FOOD, WATER, AND SHELTER, SOCIALIZATION, AND ASSISTANCE IN VETERINARY CARE SUCH AS VACCINATIONS, SPAYING AND NEUTERING. IN ADDITION, LCHS INFORMS THE PUBLIC ABOUT THE RAMIFICATIONS OF ANIMAL CRUELTY, THE CONSEQUENCES OF NEGLECT, AND THE BENEFITS OF PROPER CARE FOR ALL ANIMALS IN LEA COUNTY. FROM JANUARY 1ST THROUGH DECEMBER 31ST, 2018, IN HOBBS 2,034 DOGS AND CATS WERE RESCUED WITH 1,315 ADOPTED. FROM JANUARY 1ST THROUGH DECEMBER 31ST, 2018, IN LOVINGTON 840 DOGS AND CATS WERE RESCUED WITH 135 ADOPTED. PARTNERING WITH AMAZING GRACE PET RESCUE, CRAZY DOG LADY OF LEA COUNTY PET RESCUE, AND THE CITY OF HOBBS, LCHS SUBSTANTIALLY INCREASED TRANSPORT OF ANIMALS TO RESCUE CENTERS IN NORTHERN NEW MEXICO AND COLORADO. OVER 200 DOGS HAVE BEEN RESCUED IN THIS TRANSPORT EFFORT. ALSO WITH THE HELP OF AMAZING GRACE PET RESCUE, CRAZY DOG LADY OF LEA COUNTY PET RESCUE, AND THE CITIES OF HOBBS AND LOVINGTON, LCHS BEGAN A KENNEL SPONSORSHIP, INDIVIDUALS AND BUSINESSES MAY SPONSOR A KENNEL IN HOBBS OR IN LOVINGTON FOR 120.00 PER MONTH OR 1,200.00 PER YEAR.
