**ARTICLE I
NAME**

The name of this Non-Profit Corporation is "Gerald Champion Regional Medical Center Foundation, Inc."

**ARTICLE II
DURATION**

The period of duration of the Corporation shall be perpetual

**ARTICLE III
POWERS**

The Corporation is organized pursuant to the provisions of the Nonprofit Corporation Act of the State of New Mexico, NMSA 1978 §53-8-1 et seq and shall possess all powers and duties described therein

**ARTICLE IV
PURPOSES**

The Corporation is organized and formed for the purpose of directly supporting Otero County Hospital Association d/b/a Gerald Champion Regional Medical Center ("GCRMC") which is located in Otero County, New Mexico. The Corporation may also support programs which are affiliated with GCRMC and which further the charitable, scientific and educational purposes of GCRMC including such programs which are sponsored by other organizations described in § 501(c)(3) or §170(b)(1)(A), or in § 509(a), of the Internal Revenue Code of the United States.

The type of support given may be as follows, but shall not necessarily be limited to the following:

1. To raise money for the financial support of GCRMC.

- 2 To develop a program of planned giving for the long-range financing and endowment of GCRMC.
- 3 To improve, enlarge or reconstruct any facilities owned by, or directly related to, GCRMC.
- 4 To stimulate the interest of the residents of the Otero County area in the development of GCRMC.
- 5 To receive by gift, grant, devise and bequest, whether restricted or unrestricted, and either absolutely or in trust, any property, whether real, personal or mixed, and to hold, manage, invest and reinvest the same, or the proceeds thereof, and to apply the net income and principal thereof for the exclusive benefit of GCRMC and affiliated programs as described above.
- 6 To serve as corporate trustee of any trust in which GCMRC has a beneficial interest, and to inform and educate potential donors of the tax and other advantages of the various charitable giving vehicles permitted by state and federal law which may be used for the benefit of GCRMC.
- 7 To carry on community educational programs regarding the promotion of health, the prevention of injury, and the provision of medical care to the sick and injured, particularly as such matters relate to the health and well-being of residents of Otero County.
- 8 To award scholarships to students pursuing health-related graduate and undergraduate degrees or to medical professionals pursuing continuing education programs that will be of benefit to the Otero County community.

ARTICLE V PROHIBITED ACTIVITIES

1. The Corporation is organized exclusively for charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of the United States as it is currently stated, and shall hereafter be in force and effect. No substantial part of the activities of the Corporation shall consist of the carrying on of political propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal and state income taxes under Section 501 (c)(3) of the Internal Revenue Code of the United States as the same may be amended from time to time.
2. This Corporation shall not distribute any gains, profits, or dividends to the Directors or Officers of the Corporation or any individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distribution in furtherance of its specific and primary purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to charitable

ARTICLE VI MEMBERSHIP

This Corporation shall be a non-membership corporation.

ARTICLE VII BOARD OF DIRECTORS

1. The corporation shall be managed by its Board of Directors, the number of which shall be set forth in the Bylaws and as the Bylaws are amended from time to time. The number shall be not less than three (3) and shall be in accordance with NMSA 1978, § 53-8-18 (2012)

2. The precise number of directors and their qualifications shall be specified in the Bylaws of the Corporation. Directors shall be elected or appointed in the manner, and at the times, prescribed in the Bylaws of the Corporation.

ARTICLE VIII INDEMNIFICATION

The Corporation shall indemnify its officers and directors to the full extent permitted by law, except in relation to matters as to which he shall be guilty of misconduct in the performance of his duties as Director or officer.

ARTICLE IX BYLAWS

The Board of Directors of the Corporation shall adopt, by a majority vote, such bylaws as it deems appropriate and not inconsistent with these Articles, for the internal governance of the Corporation. No bylaw of the Corporation shall become effective until it shall have first been approved by majority vote of the Board of Directors of GCRMC.

ARTICLE X AMENDMENT

After first obtaining the approval of the governing board of GCRMC for any proposed amendment, these Articles of Incorporation may be amended by a two-thirds (2/3) majority vote of the directors of the Corporation. For this purpose, "two-thirds (2/3) majority vote of the directors of the Corporation" is defined as a two-thirds majority of the Directors in office at the time of the vote.

ARTICLE XI DISSOLUTION

Because this Corporation was organized as a charitable corporation with perpetual existence, the Corporation does not anticipate its dissolution.
