Artesia MainStreet, Inc. was organized to encourage, foster and stimulate the preservation and economic development of historic downtown Artesia, NM.

FIRST STREET GREENWAY: Eleven total acres of land is being improved with approximately 500 trees and ornamental bushes, and grass along north Highway 285. This main entry into Artesia is paralleled by a railway line, a large industrial complex and a metal scrap yard. In order to present a more positive first impression for visitors, Artesia MainStreet, Inc. has committed to create a beautiful screen along this main throughfare to greet visitors and invite them into our town.

DOWNTOWN MAINTENANCE: Artesia, NM area has a population of approximately 15,000 citizens. The downtown area encompasses 40 city blocks and includes the Derrick Floor oilfield monument and the Oilpatch Plaza, with its grounds and fountain. There are 4 additional bronze monuments in the downtown area that are part of the History in Bronze series: Sallie Chisum, known as the First Lady of Artesia, Trail Boss and the Vaquero, bringing to life the turn of the century cowboys of the Southwest and the Cattle Rustler, who may have been a contemporary of the famed Billy the Kid. All of the bronzes require periodic waxing and patina touch-ups and the brickwork and landscaping require upkeep. Artesia's Heritage Plaza and Walkway is a beautiful centerpiece in the Downtown District, containing a 7-fountain river depicting the culture of our area, represented in handmade ceramic tiles. The walls of the Walkway holds a renovated historic mural depicting our history, the textured floor is an original mural and the entire area is shaded with decorative trees and provides seating areas to encourage visitors to stay and enjoy. Artesia MainStreet is also responsible for maintenance of the grounds surrounding the new Artesia Public Library, located in the Downtown District, as well as the bronze sculpture located in the roundabout at its corner. Maintenance, repairs, utilities and insurance make up these expenses.

INDUSTRY LEARNING CENTER: During several years, under the project name Pathway to Progress, AMS funded research into the history of the oil and gas industry that is such a large part of Artesia's makeup. The plan at that time was to build an information wall/station at the Oil Patch Plaza that contained this information. As the bricks-and-mortar part of the project planning began, it became apparent that an outdoor exhibit would not be the most effective presentation of the volume of history available. A new project was created that would place an Industry Learning Center (ILC) at the Artesia Chamber of Commerce. The ILC will feature the history of not only the oil and gas industry, but also the other local industries that make up the Artesia area. Artesia MainStreet has pledged not only the research materials gathered, but also the plans for the ILC. This year's expenditures finalized the plans for the Industry Learning Center. The vision for the ILC will be an interactive learning tool for local students, citizens of our area and visitors travelling through our part of the world.
