She meets with legislators between sessions and during sessions to inform them of the NPA's position on bills related to mental health and illness and gives them related information to help them understand our position and hopefully take it into account while voting. She meets with legislative candidates during election season to assess their interest and knowledge of mental health issues and helps to educate them. She makes recommendations on candidates for small contributions from our PAC. She spends much time perusing the news and the Internet for articles of interest which she sends to the executive director, who sends it on to our members. Thus she has become an invaluable asset to our organization, the legislature and the various committees associated with the running of the state.
