3rd Crop Initiative - The core of our work, is an effort to promote alternative crops and conservation practices that supply ecological uplift and diversify the landscape while providing economic return to the family farm and supports society in general. These crops may provide food, fiber or fuel. Developing educational programming and delivering that programming through workshops, on farm demonstrations, field days, research, educational materials and one on one technical assistance to farmers are the major outreach methods we utilize. Our programming includes cover crops and drainage water management which includes saturated buffers, water storage and development of the tile outlet treatment train concept for addressing agricultural nonpoint pollution. We are evolving out programming with soil health management on farmland utilizing 3rd crop concepts

4b (Code:) (Expenses \$ 10,909.48 including grants of \$) (Revenue \$ 20,000.00)

Rural Advantage Research and Demonstration Farm - We are following out strategic plan to develop our farm and associated programming. We are demonstrating various 3rd crops management and maintenance practices. The farm is in a perennial crop rotation. We received income from the farmland and house rent which goes to pay costs of maintenance, insurance, property taxes, liability insurance and outreach programming at the farm.

Local Foods Initiative - Rural Advantage provides technical assistance and support to expand local foods programming in south central Minnesota. We coordinate the Fairmont Community Gardens with 155 20 x 20 foot plots serving about 85 families. All plots are free to community members. We assist area farmer's markets and manage a merchant terminal which can take EBT cards, they receive tokens to use with the vendors to purchase fresh produce.
