GACE was created to fulfill a mission to empower African communities through the advancement of fair trade, education, sustainable living, and gender equality. We partner with Alaffia enterprise to combat poverty and to advance gender equality through direct, long-term programs in maternal health, education and environment in West African rural communities.

GSA/USAID Sustainable Shea Initiative (SSI) Women's rural Trade Capacity Building, Reforestation & Cooperative Development
Trained 6,456 women shea collectors in Savanes region. Topics: cooperative development, health and safety, parklands management
tree nursery and reforestation operations, contract negotiations and improved processing. Constructed tree nursery in Namare, Togo
with 30,000 seedling capacity as part of SSI. 10,261 trees were planted and 13,317 were still growing in the tree nursery at year end.
This is an ongoing project started in 2017, to improve incomes and long-term resource sustainability for women shea collectors in
the African Sahel.

Safe Births Maternal Health Project GACE funded 283 women in 2018 in our program to provide antenatal, delivery and post
natal care for extremely poor mothers and babies in Togo, West Africa. Our staff partner with national health clinic staff, traditional
leaders and other local officials, as well as community volunteers. Services GACE provides include managing the enrollment books,
receiving, paying, and copying billing records for beneficiaries, and ensuring each woman has copies of all her health care records
including tests, diagnoses, vaccinations, and other treatments. GACE staff help ensure that beneficiaries receive all prescribed care.
In addition to direct services, the Safe Births program trains every beneficiary in women's and family health concerns, including
mother and infant nutrition, breastfeeding, sanitation and hygiene, birth spacing, and impacts of female circumcision (FGM).

Bicycles for Education: GACE collected 1089 bicycles from Everett, WA to Corvallis, Oregon, many of which would otherwise have
gone to US landfills. GACE shipped, repaired & donated 1,177 bicycles in 2018 to extremely poor secondary school students in Togo.
Our Bicycles for Education program addressed the extremely high dropout rate in rural West Africa. 80% of boys and 90% of girls in
Togo do not graduate secondary school. In rural areas the distance, family chores, and lack of transportation are key barriers to
education especially for girls who are burdened with daily chores like fetching wood and water, or gardening. 95% of our
bicycled students are staying in school or graduating. In 2018, GACE sold 26 bicycles to help fund the overseas shipping
costs.
