The Foundation sponsors a recreation center swim team. Throughout the year, the Foundation also helps sponsor a fundraiser in order to raise funds for the Foundation and for swim team expenses.

4b (Code _____) (Expenses \$ 25,510.50 including grants of \$ _____) (Revenue \$ 25,708.00)
The Foundation sponsors a recreation center water polo team. Throughout the year, the Foundation also helps sponsor a fundraiser in order to raise funds for the Foundation and the water polo team.

4c (Code _____) (Expenses \$ 32,305.04 including grants of \$ 22,835.04) (Revenue \$ 17,309.41)
In accordance with the Foundation's mission, grants and sponsorships are provided to organizations and to less-abled individuals, both physically and/or financially, to allow them to participate in the recreation center as well as other Board-approved projects and extracurricular activities. The largest project in 2018 was a \$10,000 grant to Cottonwood Heights City because it needed to upgrade the restrooms and shade structures in Mountview Park. The City qualified to receive \$105,000 TRCC funds (Tourism, Recreation, Culture & Convention funding from Salt Lake County) if it could also raise \$105,000. Cottonwood Heights City asked Cottonwood Heights Foundation to fund \$10,000 towards this project. The Foundation also received a \$10,711.29 restricted donation to upgrade a ball field, of which \$9,470.00 was spent in 2018.
