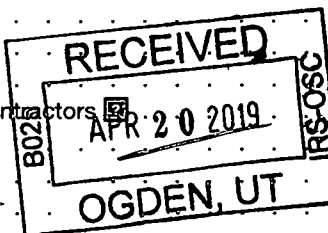

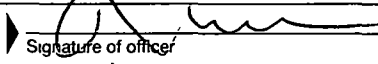

We paid the travel expenses for a group of 12 youngsters who attended a surgery week with Children of the Americas in Salama where 3 club feet were repaired as well as several other minor surgeries. In addition we supported the Primer Infancia program in the Capital - a program that serves youth 0-5 and educates their parents about nutritive foods and healthy child rearing practices. This program serves families living in marginalized areas of the Capital. Mundo Exchange supported Chajulense families to attend workshops that taught them how to grow nutritive food. At the end of the workshops participants were given seeds that provide a more diversified and nutritive food supply for the family. Monthly monitoring also occurred. Finally, funds were provided to several small villages around Chajul to complete water projects, focusing on potable water being available at the family home.
