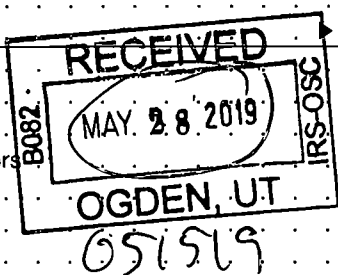

Primary Activity of the organization

The agency is an international medical care and teaching organization. We believe every woman should have the opportunity to be healed from the devastating effects of childbirth injuries. Our focus is on repairing obstetric fistulas and other pelvic floor disorders through surgery, as well as training local doctors in these life-saving techniques. Our medical team is composed of U.S. doctors & nurses volunteering their time. All services are provided free of charge.

Fifty One (51) women received medical care from medicine For Humanity in 2018.
Five (5) Ugandan surgeons received over 100 hours of surgical training in 2018.
