Community Solidarity helps to create immediate and long-term benefits for people across Long Island and the NYC metropolitan area by sharing free groceries and other necessities; and by fostering community interdependence.

Community Solidarity collects and shares free groceries directly with people in need and with other organizations whom also share free necessities directly to people in need. Our food rescue/distribution operations occurred every day in FY2018, we've worked with dozens of business who've collectively donated healthy groceries totalling over 5,386,224 lbs of food. In 2018, Community Solidarity directly shared free food with 5,300 - 5,700 people across Long Island and the NYC metropolitan area each week. Community Solidarity also shared groceries with dozens of local soup kitchens and community feeding programs. Furthermore, many families coming to our distributions saved upwards of \$120 a week off their grocery bills, providing needed flexibility for those struggling in economic hardship. In addition, our food relief programs focus on collecting and distributing health foods like fresh produce and whole grain breads.

Community Solidarity collects/shares fruit and vegetable plants, and seeds, directly to people in need across Long Island and the NYC Metropolitan area. This is done to foster sustainable food sources for people in need and to increase the general nutrition in the geographic regions of our operations. In 2018, Community Solidarity collected and distributed an estimated 440,829 pounds of plants, seeds and other gardening materials.

This expense can be seen on Part IX: Line 24(b).

Community Solidarity collects and shares new/used clothing and home goods for distribution directly to people in need across Long Island and the NYC metropolitan area. In 2018, Community Solidarity collected and distributed an estimated 145,413 items of clothing. These included thousands of winter jackets, sweaters, shoes, hats, socks, jeans and dress clothes.

Community Solidarity also distributed various home goods that included items like appliances, blankets and furniture. This also includes over 44,575 pounds of toiletry items like diapers, shampoo and tooth brushes.
